CONSULTANCY SERVICES FOR SHORT TERM INDIVIDUAL CONSULTANTS FOR THE SECONDARY EDUCATION MODERNIZATION PROGRAMME (SEMP)—MINISTRY OF EDUCATION—IDB LOAN NO. 1180/OC-TT

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO has accessed loan funding from the Inter American Development Bank Loan No. 1180/OC—TT. Two of the sub-components are Professional Development and Assessment, Testing and Evaluations which are required by the Schools Supervision Division to reform and modernize the secondary education sub-sector.

Proposals are invited from experienced educators and trainers to provide consultancy services for twenty-one (21) positions to assist with the delivery of ProD and ATE activities in the following categories:

Professional Development:

- (a) Implementation Assistants—five (5) positions.
- (b) Workshop Presenters—three (3) positions.
- (c) Education Management Trainers—three (3) positions.
- (d) Qualitative Evaluation Specialist—two (2) positions.
- (e) Training Design Specialist—two (2) positions.
- (f) Training Methodology Specialist—three (3) positions.

Assessment, Testing and Evaluation:

Evaluation Officers-three (3) positions.

The positions are to be filled on an individual basis.

Contracts will vary in length according to duties and will be of fixed value. The most extensive contract services to be provided will be for a maximum period of sixty (60) working days. This will be for one position of Implementation Assistant.

To be eligible for these positions, prospective candidates should:

- (a) possess the minimum of a first degree (as described in the Terms of Reference);
- (b) have undergone professional training (as described in the Terms of Reference) as evidenced by a certificate or diploma and/or equivalent experience [a minimum of five (5) years] in areas in which the candidate has applied;
- (c) have not worked for the Ministry of Education for at least six (6) months.
