TENDERS FOR CONSTRUCTION WORKS UNDER THE PUBLIC SECTOR IMPROVEMENT PROGRAMME 1999-2000

TENDERS are invited for the following construction works under the Public Sector Improvement Programme 1999-2000:

- (a) Completion Works of Assaraff Road Walkover, located over the Uriah Butler Highway in the vicinity of Charlieville;
- (b) Construction of a Steel Pedestrian Overpass located at Pasea Road and Churchill-Roosevelt Highway Intersection.
- 2. Tender documents may be obtained during normal working hours at the Central Tenders Board's Office, 116, Frederick Street, Port-of-Spain, Telephone Numbers 625-4330; 3565; 1809 (Fax).
- 3. Tenderers are required to pay a tender deposit of three hundred dollars (\$300.00) to the Director of Contracts and attach the official receipt to their tender.

- 5. The Chief Construction Engineer, Ministry of Works and Transport will hold a pre-tender meeting at his office at the Ministry of Works and Transport Building, Richmond Street, Port-of-Spain on Wednesday 12th July, 2000 at 10.00 a.m.
- Tenderers are required to visit the sites and acquaint themselves with site conditions, which may influence or affect their offer.Site inspections will be arranged at the pre-tender meeting.
- 7. Separate bids must be submitted for each contract. Prospective contractors may tender for projects but may be awarded only one of them.
 - 8. Prospective tenderers are advised to pay specific attention to Vol. I of IV —Instructions to tenderers.
- 9. The tender must remain valid and open for acceptance for a minimum period of one hundred and twenty (120) days after the date of tender opening.
