APPOINTMENT OF A PRIVATE WAREHOUSE

(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Kawanhar Doopan, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Private Warehouse for the storage, pending entry for export, of the following goods, as shall be warehoused by or in the Private Warehouse of Messrs. Caribbean Partnerships Co. Ltd. Spirits, Tobacco, Cigars, Perfumery, Bitters, Beer and such other goods as I may subsequently approve.

Schedule

An enclosed area measuring 5.8 metres in length and 4.5 metres in width comprising a total area of 26.1 square metres situate in the Cruise Ship Complex, Wrightson Road, Port-of-Spain.

This area, described as Shop Unit No. 27, is bounded on the south by the sea, on the west by the Port Authority of Trinidad and Tobago Transit Shed No. 2, on the north by a car park owned by the Port Authority and on the east by a building occupied by the Immigration Department, Ministry of National Security.
