COMMENCEMENT OF ELECTORAL REGISTRATION

MEMBERS OF THE PUBLIC in general and political parties and registered electors in particular, are hereby notified that under section 30 of the Representation of the People Act, Chap. 2:01, His Excellency the President has issued a Proclamation fixing Tuesday 3rd October, 2000 as the date for the commencement of an Electoral Registration in the thrity-six (36) Parliamentary Electoral Districts in Trinidad and Tobago.

In accordance with the said section 30 and Registration Rules 52 and 53, the Electoral Registration will be conducted in the various Registration Area Offices and the Temporary Registration Area Offices established for the purpose, during the period Tuesday 3rd October, 2000 to Wednesday 11th October, 2000.

The exercise is intended to facilitate those persons who-

- (a) have attained the age of 18 years and over, but who have not been registered as electors. Persons who will attain that age by 12th October, 2000 are also elegible for registration.
- (b) have been registered as electors but have changed their addresses and have not yet notified the Registration Officer of such change of address.
- (c) have been registered as electors and have changed their names because of marriage or otherwise, but their previous names appear on the Preliminary List of Electors.
- (d) have been registered as electors but their names do not appear on the Preliminary List of Electors.

During the period of the Electoral Registration, business will be conducted at the Registration Area Offices and at the Temporary Registration Area Offices, located at the addresses indicated below, as follows:

Monday to Friday-8.00 a.m. to 5.00 p.m.

Saturday and Sunday-9.00 a.m. to 3.00 p.m.

Interested persons may have their registration matters dealt with at the Registration Area Office which they normally attend, or, where it is more convenient to do so, at the Temporary Registration Area Office established to serve the constituency in which they reside.

It is important to note that at the close of business on Wednesday 11th October, 2000 no further registration or registration related matters will be effected.
