COMPENSATION in the above matter having been deposited with me under section 8 of the Workmen's Compensation Act, the dependants of the said Siew Ramkissoon are hereby required to appear before the Commissioner on Thursday The 23RD day of November, 2000, at 9.00 o'clock in the forenoon at the Court House, Port-of-Spain, when the Commissioner shall proceed to determine the distribution thereof.

Proof of relationship of dependants to the deceased workman will be required by the Commissioner to be furnished by claimants at the enquiry. Such proof to be in the form of certificates of birth and of marriage as in the circumstances be necessary.

A claimant for funeral expenses of the deceased must submit and prove his claim to the Commissioner on or before the 23rd day of November, 2000.

TENDERS FOR SCHEDULE 20—SUPPLY AND TRANSPORT OF HOT ASPHALT MIX TO JOB SITES AND DEPOTS FOR CENTRAL GOVERNMENT DIVISIONS, LOCAL GOVERNMENT BODIES, TOBAGO HOUSE OF ASSEMBLY AND CERTAIN STATUTORY BODIES FOR A PERIOD OF ONE YEAR

TENDERS are invited for Schedule 20—Supply and Transport of Hot Asphalt Mix to job sites and depots "as and when" required for a period of one (1) year for Central Government Divisions, the Tobago House of Assembly, Local Government and Statutory Bodies under the aegis of the Central Tenders Board.

- 2. Tender documents may be perused during normal working hours at the office of the Central Tenders Board, 116, Frederick Street, Port-of-Spain, but may be taken away only on production of a receipt showing that a tender deposit of fifty dollars (\$50.00), has been paid to the Director of Contracts, Central Tenders Board. The official receipt must be attached to the tender. Unsuccessful tenderers will be refunded their deposits after awards are made. The successful tenderer(s) however, will be refunded their deposits upon satisfactory completion of the contract.
- 3. Prospective tenderers who are registered for the purpose of Value Added Tax must provide a copy of their Value Added Tax Clearance Certificates.
- 4. Tenders must be accompanied by a valid Income Tax Certificate issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- 5. The successful tenderer(s) will be required to pay a Cash Performance Deposit or provide a Bond in amounts varying between \$10,000.00 and \$20,000.00 depending on the value of the contract. Cash Performance Deposits or Bonds must be provided within fourteen (14) days of the date of the Letter of Award.
- 6. The Performance Deposit/Bond will be retained until the end of the contract period and may be used to defray any excess costs that may be incurred by Government because of the contractor's failure to supply and/or to perform under the contract.
- 7. Failure to pay the Performance Deposit or provide the Bond within the stipulated period may result in the contract being declared null and void and the forfeiture of the Tender Deposit.
- 8. Sealed Tenders in duplicate on the approved Forms will be received up to 1.00 p.m. on Thursday, 14th December, 2000. Envelopes must be addressed to the Director of Contracts, Central Tenders Board, 116, Frederick Street, Port-of-Spain and marked on the outside: "Schedule 20—Supply and Transport of Hot Asphalt Mix for a period of one (1) year" and must be deposited in the Brown Tenders Box located in the lobby of the Board's Office.
 - 9. Tenders will be opened shortly thereafter. The tenderer or his representative may be present at the opening.
 - 10. Late tenders will not be considered in any circumstances.
 - 11. The Board does not bind itself to accept the lowest or any other tender.
