# APPOINTMENT OF A CUSTOMS AREA (Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Kawanhar Doopan, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Customs Area for the storage, pending consolidation for export, of the following goods, as shall be deposited by or in the Customs Area of Messrs: Cargo Consolidators Agency Limited, (i.e.) Ex-Warehouse Goods, Transhipments Goods, Re-exported Goods; Local Goods and such other goods as I may subsequently approve.

### SCHEDULE

The premises to house the Customs Area situate in the third Warehouse from the northern side of a group of six (6) Warehouses on an extension of Amazon Drive in the Point Lisas Industrial Estate in the Ward of Couva in the Island of Trinidad owned by Point Lisas Industrial Port Development Corporation Limited and leased by Cargo Consolidators Agency Limited comprises of a Mezzanine floor measuring 9.75 x 9.50 metres = 92.62 square metres; a Warehouse floor measuring 22.86 x 23.00 metres = 525.78 square metres and a Yard area measuring 22.86 x 27.00 metres = 617.22 square metres; A total area of 1235.62 square metres.

The Warehouse is constructed of a steel frame with concrete blocks and covered with galvanized sheets and is secured with Steel Louvered Gates and is also monitored electronically by a Private Security Firm.
