TENDERS are invited for the Design and Construction of the Princes Town Market for the Ministry of Local Government.

- 2. Tender documents may be perused during normal working hours at the Central Tenders Board's Office, 116, Frederick Street, Port-of-Spain, but may be taken away only on payment of five hundred dollars (\$500.00) to the Accounting Assistant, Central Tenders Board.
- 3. Prospective tenderers are required to visit the site and acquaint themselves with conditions which may influence their tenders. A pre-tender meeting/site visit is scheduled for Monday, 13th March, 2000 at 10.00 a.m. Any further technical information may be had from Mr. Raj Badhal, Project Implementation Co-ordinator, Ministry of Local Government—Telephone Number: 628-4164.
 - 4. Tenders must be accompanied by valid Income Tax and Value Added Tax Clearance Certificates.
- 5. Tenderers must submit one (1) original and copy of all Proposals. Technical and cost proposals in separately scaled small envelopes must be forwarded in one (1) large sealed envelope addressed to the Director of Contracts and marked on the outside: "Tender for the Design and Construction of the Princes Town Market, Ministry of Local Government". The smaller envelopes should be marked "Design Contract Proposal" and "Cost Proposal" respectively, and should include the name and address of the tenderers.
- 6. Sealed tenders in duplicate will be received up to 1.00 p.m. on Thursday, 23rd March, 2000 and must be deposited in the Brown Tenders Box located in the lobby of the Board's Office.
 - 7. Tenders will be opened shortly thereafter. The tenderer or his representative may be present at the opening.
 - 8. Late tenders will not be considered in any circumstances.
 - 9. The Board does not bind itself to accept the lowest or any tender.
