AMENDMENTS TO THE RULES FOR REGISTRATION AND CLASSIFICATION OF HORSES

THE TRINIDAD AND TOBAGO RACING AUTHORITY gives notice of the following amendments to the Rules for Registration of Horses (revised).

The title of the publication to read—Rules for Registration of Horses (delete reference to Classification of Horses, which no longer exists).

Rule 1—Include under "Arrears"—"or their affiliated Association"; (to be consistent with the Rules of Racing).

Change date 15th May, 1978 and replace with 1st January, 2000, appearing under "Certificate of Registration".

Change "Stud Book of England" to "English Stud Book" appearing under "General Stud Book".

Change "Stud Book of Trinidad and Tobago" to "Trinidad and Tobago Stud Book" appearing under "Stud Book".

Rule 2(c)—delete "as the proprietors of the Trinidad and Tobago Stud Book from time to time shall accept", and replace with "recognised by the Authority and the International Stud Book Committee".

 $Rule\ 3(c)$ —Reports: Fourth paragraph, second line, replace the words "a statement" with "a sworn affidavit".

(d)—Delete reference to "Fees—\$6.00 for a Covering Certificate Book", (such cost to be determined at appropriate time).

Rule 5—Foals: (a) Registration: in the third line replace the words "blood samples be taken by a Veterinarian appointed by the Trinidad and Tobago Racing Authority to determine the blood type of each foal", with "that samples of hair follicles be taken in order to determine parentage verification of each foal using the DNA mode of identification", etc.

Fifth paragraph to be deleted in its entirety; (as there is only one process of registration at Foal Stage on 15th November annually; previously foal registration took place on 30th September with another yearling registration also on 30th September of the following year).

Eighth paragraph—second line, replace the words "mare report", with "return of mares form".

(b) Fees and Penalties: replace the word "Classified" appearing in the first line of final paragraph with the words "eligible for racing".

Rule 6-Imported Horses (from outside West Indies).

Delete the words "and classification" appearing in the first line of first paragraph.

- (iii) Wherever bloodtyped appears, include "/DNA typed".
- (iv) Delete the words "effecting Classification of such horses" And replace with "being eligible to race".

Fees and Penalties

Replace \$40.00 and \$115.00 with \$110.00 and \$200.00, in the first paragraph.

Replace \$100.00 and \$175.00 with \$300.00 and \$400.00, in the second paragraph.

Replace \$500.00 with \$700.00 in the final paragraph.

Rule 7—Imported Horses (Bred in or Imported from the West Indies).

Delete the words "and classification" appearing in the first line of the first and second paragraphs respectively.

- (d) Delete entirely and replace with "Certificate of examination by an approved Veterinarian".
- (d)(i) After the words "bloodtyped"; include "/DNA typed".
- (v) Delete after the word "lodged", appearing in line 3, from "by the if needed"; and replace with "by the last working day prior to horse actually taking entry to race".

Fees and Penalties

Replace \$40.00 and \$115.00 with \$100.00 and \$200.00, in the first paragraph.

Replace \$100.00 and \$175.00 with \$300.00 and \$400.00, in the second paragraph.

Rule 11—Certificates of Registration—Change 1.5.78 to 1.1.00.

Rule 12-Names.

At end of third paragraph, after the word "dam" include "and date of birth".

Names not eligible

In the second paragraph, third line, after the word "Names", include "the List of Protected Names of Trinidad and Tobago".

Rule 13-Receipts and Certificates.

Export—Delete No. 2, and replace with "Completion of the Application Form E".

Rule 15-Reports

Geldings—Fourth line, delete from "Failure to Classification List"; and replace with "Failure to do so will result in the imposition of an automatic fine of \$100.00 on the trainer, and any such horses in training will be debarred from racing until the matter is regularised".

Death

In the first line after the word "date", include "and cause".

In the fifth line, change date from 30th September to 15th November.

Rule 16—Arrears/Agreements.

Add new section (iii), to read:

(d)(ii) No cognisance will be taken of any agreement not previously registered with the Authority, nor from any Stud Farm not registered with the Authority.
