Explanatory Note

(This note forms no part of the Bill but is intended only to indicate its general purport)

The Bill seeks to supplement the appropriation of the sum, the issue of which was authorised by the Appropriation (Financial Year 2022) Act, 2021 (Act No. 14 of 2021) as amended by the Finance (Supplementary Appropriation) (Financial Year 2022) Act, 2022 (Act No. 8 of 2022) by authorising a further issue from the Consolidated Fund in the sum of Eight Hundred and Fifteen Million, Five Hundred and Sixty-Seven Thousand, One Hundred and Sixty-Five Dollars (\$815,567,165).
