RESPONDENTS

The Petition of **DENECIA NATALIA GOPAUL- JONES** of 422 Moruga Road, Moruga, in the Republic of Trinidad and Tobago shows:

 That the Petitioner is a person who was duly registered as an elector and entitled to vote at the Local Government Election held on 14th August 2023 for the Electoral District of Lengua/Indian Walk.

- 2. That the said election was held on 14th August 2023 when Nicole Gopaul, Autly Llewelyn Granthume, and Bronson Douglas were candidates for the said election in the Electoral District of Lengua/Indian Walk. On the night of 14th August 2023, the Elections and Boundaries Commission ("EBC") announced that the said the said Autly Llewelyn Granthume received one thousand, four hundred and thirty (1,430) votes and the said Nicole Gopaul received one thousand, four hundred and twenty-five (1,425) votes.
- 3. A general recount was requested by the said Nicole Gopaul pursuant to Section 101(3) of the Election Rules. The general recount, which began on 15th August 2023, and was completed on 16th August 2023, resulted in an equality of votes, with each candidate receiving one thousand, four hundred and twenty-eight (1,428) votes.
- 4. There was one ballot which was cast in favour of the said Nicole Gopaul, but it was placed in the envelope containing the rejected ballots. The Returning Officer indicated that it was rejected on the basis that it was not initialled on the back by the Presiding Officer. Present at this first general recount was the UNC candidate's Election Agent, Mr. Alvin Lutchman, and her Counting Agent, Ms. Ashley Badal, Attorney at Law.
- 5. At the said recount, Ms. Badal and Mr. Lutchman strongly disagreed with and objected to the rejection of the ballot because the intention of the voter was clear, and there was no doubt that his "X" mark was properly and clearly placed in the appropriate place on the ballot paper to signify his vote in favour of the UNC candidate. The Returning Officer entertained and adjudicated their objection by overruling it and deeming the ballot a rejected one.
- 6. Had this ballot been accepted, it would have resulted in the said Nicole Gopaul obtaining one thousand, four hundred and twenty-nine (1,429) votes, one (1) more than the said Autly Llewelyn Granthume. If it was counted as a valid vote, the said Nicole Gopaul would have been declared and returned as the duly elected representative for the Electoral District of Lengua/Indian Walk.

- 7. Due to this ballot being rejected, and there being an equality of votes, the Deputy Presiding Officer, acting as the delegate of the Chief Elections Officer, in accordance with Election Rule 101(13), conducted another recount, which began on 17th August 2023.
- 8. During the second recount, the UNC candidate's Counting Agent for the second recount held on 17th August 2023 was Ms. Taruna Mangaroo, Attorney at Law and the said Mr. Lutchman. Ms. Mangaroo and the said Mr. Lutchman similarly disagreed with and strongly objected to the ballot's rejection by Ms. Pamela Ogiste, the Assistant Chief Election Officer, who acted as the delegate of the Chief Elections Officer during the second recount. Ms Ogiste entertained the objections and adjudicated on their objection by overruling it and deemed the ballot rejected.
- 9. The second recount was completed on 18th August 2023. The result of this count remained the same as the first recount, that is, it resulted in an equality of votes between the said Nicole Gopaul and the said Autly Llewelyn Granthume, with each person getting one thousand, four hundred and twenty-eight (1,428) votes.
- 10. Consequently, on 19th August 2023, the Returning Officer declared the election for the Electoral District of Lengua/Indian Walk, in pursuance of the writ of election issued on 9th June 2023, having received an equality of votes, void.
- 11. This petition is presented as soon as possible after the announcement on the 19th August 2023 that the Respondent had declared the election void and in any event within eight (8) days of the date on which the Returning Officer would, had there not been an equality of votes, have submitted a Return to the Poll in accordance with Election Rule 108(1)(a) of the Election Rules made pursuant to the Representation of the People Act, Chap. 2:01.
- 12. That the facts and grounds upon which the Petitioner relies are as follows:

IN THE HIGH COURT OF JUSTICE ELECTION PETITION—CONTINUED

STATUTORY FRAMEWORK:

- 13. Section 3(1) of the Representation of the People Act, Chap. 2:01 ("ROPA") provides:
 - 3. (1) Subject to section 71 of the Constitution, in the exercise of its functions under the Constitution, the Commission shall exercise general direction and supervision over the administrative conduct of elections and enforce on the part of all Election Officers fairness, impartiality and compliance with this Act.
- 14. Section 8 of the ROPA provides for the Presiding Officers and Poll Clerks.
- 15. Section 33 of the ROPA provides, *inter alia*, that an election shall be instituted by a writ of election issued by the President.
- 16. Section 35 of the ROPA provides, *inter alia*, that the elections shall be conducted in accordance with the Election Rules:
 - 35. (1) The proceedings at an election shall be conducted in accordance with the Election Rules.
 - (2) Returning Officers at elections shall do all such acts and things as may be necessary for effectually conducting elections in the manner provided by the Election Rules.
 - (3) No election shall be declared invalid by reason of any act by a Returning Officer or any other person in breach of his official duty in connection with the election or otherwise or of the Election Rules if it appears to the Court having cognisance of the question that the act did not materially affect the result of the election.
- 17. Part VI of the ROPA provides for Legal Proceedings. In particular, section 106 provides:
 - 106. (1) The following questions shall be referred to and determined by the High Court in accordance with sections 106 to 129:

(a)where leave has been granted under section 52(2) of the Constitution, any question whether any person has been validly appointed as a Senator or validly elected as a member of the House of Representatives; and

(b) any question whether any person has been validly elected as a member or to an office of a Municipal Council or of the Tobago House of Assembly.

- (2) Every such reference shall be by a petition, in this Act referred to as a representation petition.
- (3)A petition complaining of no return or an insufficient return shall be deemed to be a representation petition.
- 18. Accordingly, this being a question relating to an office of a Municipal Council, to which section 52(2) of the Constitution does not apply, there is no requirement to obtain leave to bring this Petition. Further, this Petition, which complains that there was no return, is deemed to be a representation petition under section 106(3) of the ROPA.
- 19. Finally, a representation petition may be presented by, *inter alia*, by a person who had a right to vote at the election see Section 107(1)(b)(i).

FACTS:

- 20. In consequence of sections 11(1), (4), and (4A) of the Municipal Corporations Act, Chap. 25:04 ("MCA") a Local Government Election came to be held on 2nd December 2019. Councillors and aldermen were elected for a period of 3 years, ending on 3rd December 2022. Local Government Elections were therefore scheduled to be held, in accordance with Section 11 (4A) of the MCA by 3rd March 2023.
- 21. The Miscellaneous Provisions (Local Government Reform) Act, 2022 (Act No. 11 of 2022) was assented to on 1st July 2022. By Legal Notice No. 206 of 2022, dated 7th

November 2022, certain aspects of the Act were proclaimed. Specifically, amendments to Sections 11(4) and 12(5) of the MCA, increasing the terms of councillors and aldermen by 1 year, were proclaimed. The Government and/or Cabinet argued that the effect of this was to extend the life of the incumbent councillors and aldermen by a period of 1 year.

- 22. Judicial review proceedings were initiated, which resulted in the judgment of the Privy Council in Ravi Balgobin Maharaj v the Cabinet of the Republic of Trinidad and Tobago and anor [2023] UKPC 17. The Board held that the new 4-year terms for councillors and aldermen did not apply to the incumbent councillors and aldermen.
- 23. As such, the Municipal Corporations (Extensions of Terms of Office and Validation) Act, 2023 (Act No. 4 of 2023) was passed, which, *inter alia*, provided for Local Government Elections to be held within 3 months of 18th May 2023.
- 24. Consequently, Her Excellency the President issued Her Writ for the election of members of Council under Election Rule 4(1)(a). By virtue of this, the Local Government Elections were held on 14th August 2023.
- 25. This involved and included an election of a Member of Council for the Electoral District of Lengua/Indian Walk, the subject of this Petition.
- 26. Nomination day was held on Monday 26th June 2023 and three (3) candidates were validly nominated as candidates for the election to be held in the Electoral District of Lengua/Indian Walk; Nicole Gopaul, Autly Llewelyn Granthume, and Bronson Douglas. The said poll was taken on 14th August 2023 and after the closing of the poll and the preliminary count, the EBC announced that the said Autly Llewelyn Granthume received one thousand, four hundred and thirty (1,430) votes and the said Nicole Gopaul received one thousand, four hundred and twenty-five (1,425) votes.

27. The subsequent events surrounding the counting and re-counting of the votes were summarized in a press release issued by the EBC on 19th August 2023 entitled "Fresh elections in Lengua/Indian Walk":

Fern Narcis-Scope, the Chief Election Officer, acting in accordance with Election Rule 101(15) of the Representation of the People Act, Chap. 2:01, has certified to the Returning Officer for the Electoral District of Lengua/Indian walk that the second recount, which occurred between August 17th- 18th, 2023 has resulted in an equality of votes cast between the candidates obtaining the most votes. The Returning Officer for this electoral district has declared the election void, pursuant to this certification by the Chief Election Officer, making way for fresh elections.

This historic development is as a result of the tie in the number of votes received by both the People's National Movement's and the United National Congress' candidates in the Local Government Elections. The outcome remained unchanged after two recounts of the votes cast. Both candidates received 1428 votes each.

The first recount was conducted by the Returning Officer between Tuesday 15th August and Wednesday 16th, 2023 in accordance with Election Rule 101(1) of the Representation of the People Act, Chap. 2:01.

The second recount started on Thursday 17th, 2023 in accordance with Election Rule 101 (13) which states:

Where a final count results in an equality of votes between or among the candidates obtaining the most votes, the Chef Election Officer or an officer designated by him for the purpose shall conduct a recount not later than four days after the poll.

28. During the first recount there was one contentious ballot with a vote cast in favour of the said Nicole Gopaul that was deemed to be a rejected ballot on the ground that it did not contain the initials of the Presiding Officer ("the disputed ballot"). The controversial rejection of this ballot led to the equality of votes. If it was counted as a valid vote, the said Nicole Gopaul would have been declared and returned as the duly elected representative for the Electoral District of Lengua/Indian Walk.

- 29. On 15th August 2023, at the first general recount, the UNC candidate's Election Agent, Mr. Alvin Lutchman, and her Counting Agent, Ms. Ashley Badal, Attorney at Law both attended the recount.
- 30. At the said recount, when the ballot was considered, the Returning Officer indicated that it was rejected as the ballot paper was not initialled on the back by the Deputy Presiding Officer. Ms. Badal and Mr. Lutchman strongly disagreed with and objected to the rejection of the ballot because the intention of the voter was clear, and there was no doubt that his "X" mark was properly and clearly placed in the appropriate place on the ballot paper to signify his vote in favour of the UNC candidate. The Returning Officer entertained and adjudicated their objection by overruling it and deeming the ballot a rejected one.
- 31. Furthermore, the UNC candidate's Counting Agent for the second recount held on 17th August 2023 was Ms. Taruna Mangaroo, Attorney at Law and the said Mr. Lutchman. Mr. Lutchman similarly disagreed with and strongly objected to the ballot's rejection by Ms. Pamela Ogiste, who acted as the delegate of the Chief Elections Officer during the second recount. He was ably supported by Ms Mangaroo. Ms Ogiste entertained the objections and adjudicated on their objection by overruling it and deemed the ballot rejected.
- 32. It is, therefore, clear that at both recounts, the representatives for UNC's candidate disagreed with and objected to the rejection of the ballot by the Returning Officer and the said Ms. Pamela Ogiste. Obviously, the EBC official was duty-bound to mark this ballot with a "Q" to indicate that the ballot's status is that it was "queried" by a party. The failure to do so could hardly convert what is clearly a queried ballot into an "unqueried" or unquestioned one.
- 33. By letter dated 18th August the UNC sought confirmation that the final decision of the EBC on the disputed ballot was that it was rejected because it did not bear the initials of the

Presiding Officer. The EBC replied by letter dated 19th August 2023 and indicated that "the Presiding Officer rejected the ballot as it did not bear her initials and her decision was not questioned by anyone". Furthermore, there was no objection or disagreement at the recounts to the decision to reject the disputed ballot in consequence of which there was no questioned ballot within the meaning of the Election Rules. As such, the EBC had no discretion in law to alter the rejected status of the disputed ballot.

- 34. By letter dated 20th August 2023 the UNC clarified that the representatives for its candidate did in fact object to the disputed ballot being rejected, and sought immediate clarification and full and frank disclosure from the EBC on the following issues:
 - Did the Presiding Officer invoke the power given by Election Rule 97 (4) and utilize the procedure set out therein when she discovered that she had omitted to affix her initials to the back of the subject ballot? If she did, why was the ballot not simply initialled and counted?
 - What was the reason for the rejection of the ballot? The statement that she "rejected the ballot as it did not bear her initials and the decision was not questioned by any candidate or his agent" is ambiguous because it cleverly ignores or overlooks Election Rule 97 (4).
 - Kindly indicate the precise ground in Election Rule 97 (2) or Election Rule 97 (4) that was relied on to reject this ballot.
 - Why was the ballot not marked with the letter "Q" to signify that it was a queried ballot in light of the objections made on both occasions?
- 35. By letter dated 20th August 2023 the EBC replied to indicate the following:

It should be noted that Polling Station 3580-2 was designated for intermixing of special ballots. This means that not every ballot in the box would have had the initials of the Presiding Officer. It does not follow therefore that if a ballot does not have the initials of the Presiding Officer that it was an error or omission on the part of the Presiding Officer.

At the first recount conducted by the Returning Officer, the rejected ballot in Polling Station 3580-2 was deemed rejected by the Returning Officer who agreed with the original decision of the Presiding Officer that the ballot should be rejected as it had no polling station number and no initials of the Presiding Officer, the Deputy Presiding Officer or even the Returning Officer. At that point in time none of the parties had any objections to the ballot being rejected and the ballot box for that Polling Station was sealed and the count continued. No party representative requested that the Returning Officer write the letter "Q" followed by his initials on the back of the ballot pursuant to Election Rule 101(7).

At the end of the recount for Polling Station 3581-1 the UNC representative Ms. Ashley Badal expressed the view that the rejected ballot in Polling Station 3580-2 should be counted as it clearly indicated the candidate for whom the elector voted.

The PNM representative Mr. Colin Partap stated that any objections as to the validity of the ballot should have been stated on the night of the count by the agents. She ended by stating that she would be writing the EBC in relation to the matter.

At the second recount conducted by the Assistant Chief Election Officer, the rejected ballot found in Polling station 3580-2 was deemed rejected by the Assistant Chief Election Officer who agreed with the decision of the Returning Officer that the ballot should be rejected as it had no polling station number and no initials of the Presiding Officer, Deputy Presiding Officer or the Returning Officer. The UNC representative Mr. Alvin Lutchman stated that the intention of the voter was clear and it should not have been rejected. The PNM representative, Mr. Randall Mitchell stated that there was ample opportunity for that ballot to have been noticed throughout the voting process as well as an opportunity for the Presiding Officer to have corrected it if it needed correction during the count. The Assistant Chief Election Officer listened to the arguments from both sides and stated that she stands by the decision of the Returning Officer that the ballot should remain rejected. No party representative requested that she write the letter "O" followed by her initials on the back of the ballot.

36. The Petitioner shall contend that the EBC is guilty of constantly shifting the goalpost and has breached its duty to make full and frank disclosure on matters of critical importance as illustrated by its unhelpful, evasive, equivocal and ambiguous responses, and that it is under a duty to make full and frank disclosure.

GROUNDS:

- 37. This petition humbly asks this Honourable Court to determine whether the said Nicole Gopaul received the highest number of votes cast and was hence validly elected as a Councillor for the Electoral District of Lengua/Indian Walk in the Princes Town Regional Corporation pursuant to section 106(1)(b) of the RPA.
- 38. Further and/or alternatively this petition humbly complains to this Honourable Court of there being no return to the election for the Electoral District of Lengua/Indian Walk pursuant to section 106(3) of the RPA in circumstances where the UNC's candidate Nicole Gopaul received the highest number of votes cast.
- 39. Ms. Nicole Gopaul's representatives who were present at both recounts submitted that there was no lawful justification for invalidating the said ballot because the intention of the voter was clear and the failure and/or omission of the Presiding Officer to initial same was not a lawful basis for rejecting the ballot. At best, this was but a mere administrative irregularity on the part of the EBC's official that could not disenfranchise the voter who exercised his/her right to vote in favour of the candidate of his/her choice.
- 40. On 15th August 2023, at the first general recount, Ms. Gopaul's Election Agent, Mr. Alvin Lutchman, and her Counting Agent, Ms. Ashley Badal, Attorney at Law both attended the recount.

- 41. At the said recount, when the ballot was considered, the Returning Officer indicated that it was rejected as the ballot paper was not initialled on the back by the Presiding Officer. Ms. Badal and Mr. Lutchman strongly disagreed with and objected to the rejection of the ballot because the intention of the voter was clear, and there was no doubt that his "X" mark was properly and clearly placed in the appropriate place on the ballot paper to signify his vote in favour of the UNC candidate. The Returning Officer entertained and adjudicated their objection by overruling it and deeming the ballot a rejected one.
- 42. Furthermore, the Ms. Gopaul's Counting Agent for the second recount held on 17th August 2023 was Ms. Taruna Mangaroo, Attorney at Law and the said Mr. Lutchman. Ms. Mangaroo and Mr. Lutchman similarly strongly disagreed with and objected to the ballot's rejection by Ms. Pamela Ogiste, who acted as the delegate of the Chief Elections Officer during the second recount. Ms Ogiste entertained the objections and adjudicated on their objection by overruling it and deemed the ballot rejected.
- 43. It is, therefore, clear that at both recounts, the UNC candidate disagreed with and objected to the rejection of the ballot by the Presiding Officer and the said Ms. Pamela Ogiste (acting as the delegate of the Chief Elections Officer under Rule 101(13)). These were substantial objections.
- 44. Obviously, the EBC official was duty-bound to mark this ballot with a "Q" to indicate that the ballot's status is that it was "queried" by a party. The failure to do so could hardly convert what is clearly a queried ballot into an "unqueried" or unquestioned one.
- 45. Moreover, the said ballot cannot be considered as falling within any of the categories of ballots which should be rejected under Election Rule 97(2) and the mere reason that it did not bear the initials of the Presiding Officer is not a basis for disqualifying it under those Rules.
- 46. Assuming but not admitting that Ms Badal made her objection at the end of the first recount, the Returning Officer was duty-bound to mark this ballot with a "Q" to indicate that the ballot's status is that it was "queried" by a party. It was clear that she was objecting to the rejection of the disputed ballot and the process was not yet at an end.

IN THE HIGH COURT OF JUSTICE ELECTION PETITION—CONTINUED

- 47. Likewise, Mr Alvin Lutchman's objection ought to have been taken into account and dealt with on its merits instead of taking the position that "there was no questioned ballot within the meaning of the Rules" and hence Rule 101 (15) applied.
- 48. Each recount should have been done *de novo* with a fresh consideration by an independent official who had to review and count each ballot. Representatives were free to object to the proposed rejection of any ballot. There is no rule which states that the representatives of the candidates are deemed to have waived their right to object to a rejected ballot if they had previously failed to do so.

Special Electors

- 49. Part IV of the Election Rules deal with the issue of special voting. It sets up a detailed and comprehensive code to regulate and govern special voting with numerous checks and balances that are designed to protect the integrity of the process and ensure that only persons who are registered to vote as special electors are allowed to do so using a validly issued ballot.
- 50. Special voters must make an application to the Returning Officer who will determine whether he should allow him to be treated as a special elector (Rule 62). The Ballot papers provided by the EBC to the Returning Officer carry a serial number (Rule 65 (b)).
- 51. Rule 69 deals with the marking of the ballot paper:
 - 69. As each ballot paper is issued, the name and number of the special elector on the list of special electors shall be called out and the Returning Officer shall mark the number on the stub of the ballot paper, and shall place the initial letters of his names on the ballot paper in the place reserved therefor; and a mark shall be placed on the said list against the number of the elector to denote that a ballot paper has been issued to the elector but without showing the particular ballot paper issued.

IN THE HIGH COURT OF JUSTICE ELECTION PETITION—CONTINUED

52. Rule 82 deals with the procedure for special voting:

- 82. Before a special elector is permitted to cast his vote, the Special Presiding Officer shall, after the special elector has identified himself—
 - (a) request the special elector to supply his name and address and occupation, and where the polling station is established under rule 76, the electoral district for which he is a special elector, the covering envelope and if available, his identification card; (b) check the list of special electors for that electoral district supplied to him by the Chief Election Officer to establish whether there is an entry corresponding to the information given;
 - (c) where the check required by paragraph (b) establishes the information given, request him to display—
 - (i) the ballot paper in his possession so as to ensure that it has not yet been marked for any candidate, and if unmarked, that it bears an initial in the area reserved for signature of the Returning Officer;
 - (ii) the covering envelope bearing the address of the Returning Officer for his electoral district with the declaration of identity;
 - (d) request him to complete and sign the declaration of identity on the outside of the covering envelope, compare the signature with that on the identification card if presented and sign the declaration of identity in the space provided for the signature of the Special Presiding Officer;
 - (e) provide the special voter with the stamp or any other writing instrument for him to mark the ballot for the candidate of his choice and then direct him to the area provided for voters to mark their ballot in secrecy and instruct him in the form in which it is to be folded when being returned;

IN THE HIGH COURT OF JUSTICE ELECTION PETITION—CONTINUED

(f) after the special elector has marked his ballot paper and displayed the folded ballot, the Special Presiding Officer shall ensure that the folded ballot bears the initial of the Returning Officer in the space provided, request him to place it first in the envelope provided for the ballot and the two into the covering envelope addressed to the Returning Officer for the appropriate electoral district and after sealing same cause him to insert it into the special ballot box;

(g) every Special Presiding Officer shall keep a record at a special polling station in which he shall enter the name, address and identification card number, if available, of a special elector and whether or not the special elector has voted and he shall cause every special elector who has voted at that special polling station to sign the entry referred to in this paragraph.

- 53. Rule 84 deals with the procedure after the close of the special polling station and sets out a detailed procedure to ensure that Special Presiding Officer counts and records the number of ballots cast in the presence of at least one witness so that there is a contemporaneous record of the special ballots cast.
- 54. Rule 85-86 deal with the transmission of ballots to the various Returning Officers and the procedure they must follow when they receive same.
- 55. Rule 90 deals with the procedure that the Presiding Officer must follow when opening the special ballots:
 - 90. (1) The Presiding Officer shall then separately open each covering envelope contained therein.
 - (2) Where the envelope does not contain a ballot paper the Presiding Officer shall mark the covering envelope "No ballot paper" and also "rejected" and attach thereto the contents (if any) of the envelopes, and place the same into a separate receptacle (hereinafter referred to as "the receptacle for votes rejected").
 - (3) Where the envelope does contain a ballot paper the Presiding Officer shall satisfy himself that—

- (a) the declaration of identity printed on the covering envelope has been duly signed;
- (b) the signature on the declaration of identity corresponds with the signature on the registration record of the elector in the register of special electors;
- (c) that the initials appearing on the ballot paper are the initials of the Returning Officer.
- (4) If the Presiding Officer is not satisfied as in subrule (3), he shall-
 - (a) mark on the covering envelope the word "rejected" if his dissatisfaction is in respect of subrule (3)(a) and (b);
 - (b) mark the ballot paper "rejected" if his dissatisfaction is in respect of subrule (3)(c);
 - (c) show the declaration and the registration record to the persons authorised by the *Presiding Officer* to be present;
 - (d) place the covering envelope in the receptacle for votes rejected;
 - (e) add the words "rejection objected to" and the letter "Q" to the covering envelope if an objection is made by a candidate or an election agent or any counting agent to his decision.
- (5) If the Presiding Officer is satisfied as in subrule (3), he shall—
 - (a) place the covering envelope on which the declaration of identity is printed in a separate receptacle (hereinafter referred to as "the receptacle for covering envelopes");
 - (b) place the ballot paper in the special ballot box;
 - (c) mark the letter "V" opposite the name of the elector on two copies of the list of special electors.

- 56. Rules 92 and 93 also provide for detailed and accurate recording in the polling station diary of the "intermixing" process which guarantees that only properly issued special ballot that have been checked to the satisfaction of the special presiding officer are placed into the ballot box at the intermixing station.
- 57. By Rule 97(4) of the Election Rules, the Presiding Officer is under a statutory duty and must follow the procedures therein. Rule 97 (4) states as follows:
 - (4) Where in the course of counting the ballots a Presiding Officer discovers that he had omitted to affix his initials to the back of the ballot at the time it was issued he shall in the presence of the Deputy Presiding Officer and the Poll Clerk and the candidates or their agents affix his initials to the ballot and **count the ballot** if he is satisfied that—
 - (a) the ballot paper is one that has been supplied by him;
 - (b) an omission has really been made; and
 - (c) every ballot paper supplied to him by the Returning Officer has been account for.
- 58. The Election Rules, which must be complied with strictly, expressly provide for the specific circumstances in which a ballot may be rejected. In particular, Rule 97(2) provides as follows:
 - (2) In counting the votes the Presiding Officer shall **reject** all ballots –
 - (a) that are on ballot papers that have not been supplied by him;
 - (b) that have not been marked for any candidate or have not been stamped or marked in the manner prescribed;
 - (c) on which votes have been given for more than one (1) candidate;
 - (d) where it cannot be established for whom the elector has voted;
 - (e) upon which there is any writing or mark by which the elector can be identified.
- 59. Further, Rule 97(4) mandates the Presiding Officer to insert his/her initials if he/she discovers that it was omitted from a ballot and count the ballot provided if he/she is satisfied that the prescribed criteria are met. The ballot would also be subject to being rejected under Rule 97(2).

- 60. Those circumstances are that the Presiding Officer must have been satisfied of the following:
 - (a) The ballot paper is one that has been supplied by him;
 - (b) An omission has really been made; and
 - (c) Every ballot paper supplied to him by the Returning Officer has been accounted for.
- 61. The language used in Rule 97(4) is mandatory in nature. The use of the word "shall" means that the Presiding Officer was obliged and had no choice but to follow the procedure contained therein.
- 62. There is no question that the disputed ballot was a *bona fide* ballot issued by the EBC. The procedure for both regular and special voting is such that the election official must be able to reconcile the number of ballots cast with the number of persons who voted. In the case of special ballots, there are additional safeguards in that the special voter is required to personally sign twice and make a declaration of his identity. This makes the reconciliation exercise even more transparent and accountable.
- 63. Further, on a general recount, the law provides for a Returning Officer to vary the decision of the Presiding Officer with respect to any ballot, including a rejected ballot. Rule 101(6) states:
 - Where a general count is conducted the Returning Officer shall review all ballots including rejected ballots, counted by the Presiding Officer at the polling stations specified in the request for the count and where he disagrees with the decision of the Presiding Officer as regards any ballot he shall write the word "varied" at the back of the ballot.
- 64. From the Statement of the Polls, the ballot in question was and could only be the one that was rejected. It is clear that there was a failure and/or omission by the relevant election official to affix his/her initials to the said ballot.

- 65. At best, this was but a mere administrative irregularity on the part of the EBC's official that could not disenfranchise the voter who exercised his right to vote in favour of the candidate of his/her choice. The common law principles that govern elections are relevant and applicable and hence mere irregularities cannot and will not operate in law to vitiate the clear and express intention, will and political preference of the voter. The Respondents breached their official duty by failing and /or refusing to mark and treat the disputed ballot as a Queried Ballot in light of the objections raised by the UNC's candidate at both recounts.
- 66. There is no requirement for agents of the candidates (or anyone else for that matter), to raise any objection with respect to a ballot that is missing the initials of the Presiding Officer. Indeed, Rule 97(4) specifically provides for the Presiding Officer to initial the ballot once *she* discovers it is missing if she is satisfied that the relevant criteria has been met. This power will extend to any other election official who is charged with performing similar duties under the Rules. To suggest otherwise would place special voters in an extremely disadvantageous situation which the law could not have possibly intended.
- 67. A ballot without the initials of the relevant election official which could not be accounted for cannot be counted. However, there is no lawful justification for disenfranchising a legitimate voter by rejecting his ballot because of an inadvertent or negligent error or omission on the part of the EBC's officials.
- 68. In the circumstances, the Respondents acted unlawfully and illegally in rejecting the disputed ballot. The Commission seems to have shifted the goalpost. In its letter of 19th August 2023 it stated that the ballot was rejected because it did not bear the initials of the Presiding Officer. In its letter of 20th August 2023 it seems to be suggesting that the disputed ballot was a special ballot which was rejected because it did not carry a polling station number and did not bear the initials of any election official, and as such, by virtue of Rule 90 (3) (c) and (4), they had no choice but to reject the ballot.
- 69. If the EBC's officials failed to initial the disputed ballot, the procedure for special voting outlined in Rule 82 is so tight that in the absence of a discrepancy which suggests that the disputed ballot is a fake, the Respondent was obliged to give effect to the clear intention of the voter.

IN THE HIGH COURT OF JUSTICE ELECTION PETITION—CONTINUED

70. From the Statement of the Poll the total number of ballots found in the Box was 278. There were 87 special ballots. That station received 550 ballot papers and 359 were not used. That means 191 ballots were cast in the station.

The box had 278 ballots

Cast in station - 191 ballots

Special ballots - 87 191 + 87 = 278

- 71. The ballot in question was accounted for as a rejected ballot on the Statement of the Poll.

 The ballots in the box were reconciled with the station ballots and the special ballots.
- 72. Assuming, but not admitting that there was no objection the rejection of the disputed ballot, this does not bind registered electors who all have the requisite locus standi to bring an election petition. The court certainly has jurisdiction (both statutory and at common law) to adjudicate on the legal validity of the disputed ballot and can hence deal with the issues raised in this petition. The court's jurisdiction is neither circumscribed by nor conditional upon whether there was an objection to the disputed ballot. The validity of a ballot is a question of law and the failure to object could hardly validate an invalid ballot and vice versa.
- 73. The absence of the initials of the relevant EBC official(s) is but a mere irregularity on the part of the EBC that does not operate in law to invalidate the disputed ballot where the intention of the voter was quite clear. The law takes cognizance of the fact that such irregularities can and will occur at elections.
- 74. Unless there is some exceptional basis for rejecting a vote on one of the statutory grounds prescribed in the Act and Rules, the court strives to save the vote because the overriding objective is to respect and give effect to the intention and preference of the voter. The failure on the part of the EBC's officials to initial the disputed ballot is not a prescribed ground for rejecting the disputed ballot.

IN THE HIGH COURT OF JUSTICE ELECTION PETITION—CONTINUED

75. In the premises, the disputed ballot ought not to have been rejected; it should have been counted as a valid vote which would have resulted in the said Nicole Gopaul obtaining one thousand, four hundred and twenty-nine (1,429) votes. In accordance with the Representation of the People Act and the Election Rules made thereunder, the said Nicole Gopaul ought to have been duly elected and returned as the councillor for the Electoral District of Lengua/Indian Walk.

76. The Petitioner therefore prays:

- 1. That it may be determined that the disputed ballot was valid and ought to have been counted in consequence of which Nicole Gopaul was duly elected and returned for the Electoral District of Lengua/Indian Walk;
- 2. Consequently, that it may be determined and declared that the said election is not void.
- 3. That the Honourable Court grant all necessary and consequential orders and directions and such further and/or other relief as the Court shall deem fit.

In Compliance with sections 7,8 & 9 of

the Freedom of Information Act (FOIA) Chap 22:02 updated to 2023

In accordance with Sections 7, 8 & 9 of the Freedom of Information Act (FOIA) Chap 22:02, The Environmental Commission of Trinidad and Tobago ("The Commission") is required by law to publish the following statements which list the documents and information generally available to the public.

The FOIA gives members of the public:

- A legal right for each person to access information held by the Commission.
- A legal right for each person to have official information relating to him/herself amended where it is incomplete, incorrect or misleading.
- A legal right to obtain reasons for adverse decisions made regarding an applicant's request for information under the FOIA.
- A legal right to complain to the Ombudsman and to apply to the High Court for Judicial Review to challenge adverse decisions made under the FOIA.

Section 7 (1) (a) (i)

Function and Structure of the Environmental Commission of Trinidad and Tobago

Structure of the Commission:

The Commission is a Superior Court of Record established by the Environmental Management Act (The EM Act") Chap 35:05 and has in addition to the jurisdiction and powers conferred on it by the EM Act, all the powers inherent in such a Court. The Commission has the power to enforce its own orders and judgments, and the same power to punish contempts as the High Court of Justice.

The Environmental Commission consists of six members who hear and determine environmental matters brought before the Court. Its Chairman and Deputy Chairman must be attorneys-at-law of not less than ten years standing. The other members must have knowledge and experience in environmental issues, engineering, urban and regional planning, the natural sciences or the social sciences. All six members are appointed by the President to hold office for term of not less than three years (Section 81 EM Act and section 14 of the Planning and Facilitation of Development Amendment Act 2019).

Functions of the Commission:

The Commission shall have jurisdiction to hear and determine—

- a) Appeals from decisions or actions of the Environmental Management Authority (EMA). Persons may challenge the EMA's findings, decisions and actions by appealing to the Commission.
- b) Applications for a deferment of a decision of the EMA under sections 25 and 41 of the EM Act 2000. Under Section 25, the EMA is authorized to make a decision to undertake emergency response activities as required to protect human health or the environment against threat of a pollutant,

hazardous substance or any other environmental condition. Under Section 41, the EMA may make a decision to designate portions of the environment as an environmentally sensitive area or species. When the EMA has made such decisions under sections 25 and 41 of the EM Act, the person who is affected by that decision, may apply to the Commission for a deferment of the decision on the grounds that it was unreasonable by section 88 (1) of the EM Act.

- Applications by the EMA for enforcement of the Consent Agreements and Final Administrative Orders under section 67 of the EM Act.
- d) Administrative civil assessments under Section 66 of the EM Act.
- e) Appeals from the designation of "environmentally sensitive areas or environmentally sensitive species" by the Authority pursuant to section 41 of the EM Act.
- f) Appeals from a decision by the Authority under section 36 of the EM Act, to refuse to issue a Certificate of environmental clearance or to grant such certificate with conditions.
- g) Appeals from any determination by the Authority to disclose information or materials claimed as a trade secret or confidential business information under section 23(3) of the EM Act 2000.
- h) Complaints brought by persons pursuant to section 69 of the EM Act known as the Direct Private Party Action provision. It is the only type of action before the Commission that does not involve the EMA as a party since one private individual brings an action against another private individual.
- i) Such other matters as may be prescribed by or arise under the EM Act, or any other written law where the jurisdiction of the Commission is specifically provided, such as the Urban and Regional Planning Profession Act No. 22 of 2020 and the Planning and Facilitation of Development Act No. 10 of 2014.


