## NOTIFICATION OF THE APPROVAL OF A BONDED AREA (Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chapter 78:01, I, Yasmin Harris, Acting Comptroller of Customs and Excise, acting under the provisions of Regulations 193 of the said Act, do hereby approve the place specified in the schedule hereto to be a Bonded Area for the storage of imported coil nails by Messrs. Mun-Chin Enterprises Limited for the manufacture of wooden pallets for home consumption or export.

#### SCHEDULE

A flattop concrete structure of cement blocks located on the north-western corner enclosed within the factory measuring 21.2 metres in width by 42.4 metres in length with walls made of concrete blocks and galvanized sheeting and a roof made of galvanized sheeting and steel; of Mun-Chin Enterprises Limited located at 37–39 Boucaud Trace, Penal Rock Road, Penal. The said concrete structure measuring 3.35 metres in width by 7.21 metres in length by 2.5 metres in height with a sliding door measuring 1.60 metres in width by 2.13 metres in length for entry/exit and a floor space comprising of 24.15 square metres.

The area is bounded on the east by an open space within the factory, on the west by the western wall of the factory, on the north by the northern wall of the factory and on the south by an office.
