THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(VII COMMONWEALTH YOUTH GAMES) ORDER, 2023

PART I

TAROUBA, SAN FERNANDO

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (VII Commonwealth Youth Games) Order, 2023.

2. This Order has effect between— Duration

- (a) 7.00 a.m. to 2.00 p.m. on Friday 4th August, 2023;
- (b) 7.00 a.m. to 3.00 p.m. on Saturday 5th August, 2023; and
- (c) 7.00 a.m. to 7.00 p.m. on Monday 7th August, 2023.

3. Vehicular traffic and parking are prohibited along the Brian Lara Boulevard, which leads to the Brian Lara Stadium. Vehicular traffic and parking prohibited

4. Parking is prohibited on the Gasparillo Bypass Road. Parking prohibited

PART II

BUCCOO, TOBAGO

5. This Order has effect between— Duration

- (a) 5.00 a.m. and 7.00 p.m. on Thursday 3rd August, 2023;
- (b) 5.00 a.m. and 7.00 p.m. on Saturday 5th August, 2023;
- (c) 5.00 a.m. and 7.00 p.m. on Sunday 6th August, 2023;
- (d) 5.00 a.m. and 7.00 p.m. on Monday 7th August, 2023; and
- (e) 5.00 a.m. and 7.00 p.m. on Tuesday 8th August, 2023.

6. Vehicular traffic and parking are prohibited on—

- (a) Buccoo Main Road between Cadiz Road and Battery Street;
and
- (b) Periwinkle Drive between Buccoo Main Road and Begonia
Avenue.

7. Without prejudice to any other liability incurred by the commission of a traffic violation, vehicles found parked in contravention of this Order may be removed by the police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
