LIST OF REGISTRANTS AS AT 31ST MARCH, 2024

The Trinidad and Tobago Securities and Exchange Commission ("the Commission") is responsible for the oversight of the securities industry ensuring that it operates in a fair, transparent and efficient manner in order to protect the rights of investors.

The Commission regulates the securities market by registering all securities that are distributed to the public, all issuers of those securities, and market intermediaries directly involved in the issuance, offering and sale of those securities e.g., *Broker-Dealers, Investment Advisers, Underwriters, and Self-Regulatory Organisations*. Certain employees or officers of Broker-Dealers, Investment Advisers and Underwriters are also required to be registered with the Commission as Registered Representatives.

HOW DOES REGISTERING WITH THE COMMISSION PROTECT INVESTORS?

The registration process requires all registrants (issuers of securities as well as market intermediaries such as *Broker-Dealers, Investment Advisers*, and *Underwriters*) to provide the Commission with pertinent information regarding the registrant itself (such as background information on its operations, management and financial position) as well as any securities that the registrant intends to distribute. The Commission ensures that the information meets the requirements of the law and is available to the public.

Firms and individuals are registered by category – each registration category attracts different educational, experience, and financial requirements, and permits the registrant to conduct different activities. The Commission ensures that the companies are genuine entities with a registered office, staffed by qualified professionals who possess the knowledge, skills and experience to conduct the class of business for which the companies are being registered.

WHAT ARE THE QUALIFICATIONS FOR REGISTRATION?

Registration will not be granted unless the Commission is satisfied that an applicant is fit and proper, meets the requirement of the law with respect to capital and educational qualifications, and discloses any information that may affect the conduct and integrity of the applicant's business. This information is also available for public viewing at the Commission.

The provision of information does not end after the initial registration. Registrants are required to continuously provide the Commission, as well as investors, with information inclusive of changes which may positively or negatively impact the performance of their business and the securities available to investors.

IS REGISTRATION AN ENDORSEMENT?

While we advise investors to deal only with registrants that are registered with the Commission, registration with the Commission is NOT an endorsement of the registrant or of any security. The Commission provides neither guarantee nor opinion on the performance of a registrant or security.

Always remember, even though you are dealing with someone who is registered with the Commission, you should evaluate the registrant and the securities being offered and if necessary, seek independent financial advice before making an investment decision.

DEFINITION OF TERMS

Broker-Dealer

A firm acting as an intermediary between a buyer and a seller of securities, usually for a fee or a commission. When acting as a broker, a Broker-Dealer executes orders on behalf of their client. When acting as a dealer, a Broker-Dealer executes trades for the firm's own account.

Investment Adviser

An individual or firm that advises clients on investment in, or the purchase or sale of securities on a professional basis.

Underwriter

A company that arranges for the issuance or distribution of securities and/or agrees to purchase any unsold securities thereby guaranteeing subscription either in full or in part.

Registered Representative

An employee or officer of a registered Broker-Dealer, Investment Adviser or Underwriter who liaises with members of the public on behalf of their employers further to the offering, distribution or sale of securities.

Sponsored Broker-Dealer or Sponsored Investment Adviser

An individual who is employed by a Brokerage or Investment firm from a foreign jurisdiction. This individual aligns with a local Broker-Dealer or Investment Adviser who sponsors that individual's registration with the Commission. A Sponsored Broker-Dealer or Sponsored Investment Adviser that is registered with the Commission can conduct securities business in Trinidad and Tobago for a maximum of ninety (90) days in a calendar year.

Reporting Issuer

A corporation that has distributed or proposes to distribute securities to the public and is subject to the continuous disclosure requirements of the Commission.

Self-Regulatory Organisation

A non-governmental organisation that has the power to create and enforce industry regulations and standards. The priority is to protect investors through the establishment of rules that promote ethics and equality.

In accordance with the requirements of Section 52(8) of the Securities Act, Chapter 83:02 of the Laws of the Republic of Trinidad and Tobago, the Commission provides the undermentioned list of its Registrants and Self-Regulatory Organisations as at 31st March 2024.

In compliance with Sections 7, 8 and 9 of the Freedom of Information Act (the "FOIA").

In accordance with Sections 7, 8 and 9 of the Freedom of Information Act (the "FOIA") the Trinidad and Tobago Securities and Exchange Commission (the "Commission") is required by law to publish the following statements, which list the documents and information generally available for public scrutiny.

The FOIA gives members of the public a legal right:

- A legal right for each person to access information held by the Commission;
- A legal right for each person to have official information relating to himself/herself amended where it is incomplete, incorrect or misleading;
- 3. A legal right to obtain reasons for adverse decisions made by the Commission regarding an applicant's request for information under the FOIA; and
- 4. Upon a Notice of Refusal, a legal right to complain in writing to the Ombudsman and to apply to the High Court for Judicial Review to decisions made under the FOIA.

UPDATED PUBLIC STATEMENT OF THE TRINIDAD AND TOBAGO SECURITIES AND EXCHANGE COMMISSION 2024—CONTINUED

Vision

To be an innovative regulator of a thriving securities market, enabling economic development for the benefit of all.

Core Values

Instilling confidence in the securities market by protecting investors, promoting sustainable market growth, and reducing systemic risk, through collaboration and innovation.

Functions of the Commission

The Commission was first established, by the Securities Industry Act, 1995 ("SIA 1995") in 1997 and continued under the Securities Act, Chapter 83:02 of the Laws of the Republic of Trinidad and Tobago ("SA") as a body corporate to regulate the securities market in Trinidad and Tobago.

The Commission's main functions, as outlined in Section 6 of the SA are to:

- advise the Minister of Finance on matters relating to the securities industry;
- maintain surveillance over the securities industry and ensure orderly, fair and equitable dealings in securities;
- register, authorise or regulate, in accordance with the SA, self-regulatory organisations, broker-dealers, registered representatives, underwriters, issuers and investment advisers; and control and supervise their activities with a view to maintaining proper standards of conduct, and professionalism in the securities industry;
- regulate and supervise the timely, accurate, fair and efficient disclosure of information to the securities industry and investing public;
- conduct such inspections, reviews and examinations of self-regulatory organisations, brokerdealers, registered representatives, underwriters, issuers and investment advisers as may be necessary for giving full effect to the SA;
- protect the integrity of the securities market against any abuses arising from market manipulating practices, insider trading, conflicts of interest, and other unfair or improper practices;
- educate and promote an understanding by the public of the securities industry and the benefits, risks, and liabilities associated with investing in securities;
- co-operate with, and provide assistance to other regulatory authorities in Trinidad and Tobago, or elsewhere;
- ensure compliance with the Proceeds of Crime Act, any other written law in relation to the
 prevention of money laundering and combating the financing of terrorism or any other written
 law that is administered or supervised by the Commission;

- create and promote such conditions in the securities industry as may seem to it necessary, advisable or appropriate to ensure the orderly growth and development of the securities industry and to further the purposes of the SA;
- co-operate with other jurisdictions in the development of a fair and efficient securities industry; and
- assess, measure and evaluate risk exposure in the securities industry.

Powers of the Commission

- 7 (1) For the purpose of the discharge of its functions, the Commission has power pursuant to Section 7 of the SA to:
 - (a) formulate principles for the guidance of the securities industry;
 - (b) treat with such matters as may be referred to it by any person from time to time;
 - (c) register and regulate market actors in accordance with this Act;
 - (d) monitor the solvency of registrants that are entities, securities markets and selfregulatory organisations and take measures to protect the interest of investors where the solvency of any such person is in doubt;
 - (e) adopt measures to supervise and minimise any conflict of interest that may arise in the case of registrants or self-regulatory organisations and where appropriate other market actors;
 - (f) review, approve and regulate takeovers, amalgamations and all forms of business combinations in accordance with this Act or any other written law in all cases in which it considers it expedient or appropriate to do so;
 - (g) review the contents of prospectuses and issue receipts therefor, and review any form of solicitation, advertisement or announcement by which securities are proposed to be distributed;
 - (h) take enforcement action against any person for failing to comply with this Act;
 - (i) recommend Bye-laws to the Minister;
 - (j) formulate, prepare and publish notices, guidelines, bulletins and policies describing the views of the Commission regarding the interpretation, application, or enforcement of this Act;
 - (ja) formulate, prepare and publish guidelines in respect of declared agreements;
 - (k) make orders; (l) monitor the risk exposure of registrants and self-regulatory organisations and take measures to protect the interest of investors, clients, members and the securities industry;
 - (m) undertake such other activities as are necessary or expedient for giving full effect to this Act; and
 - (n) do all things, and take all actions, which may be necessary, expedient, incidental or conducive to the discharge of any of its functions and the exercise of its powers under this Act.
 - (2) The Commission may, in writing require any market actor to furnish it with such information as it may require for the exercise of its functions within such time and verified in such manner as it may specify.

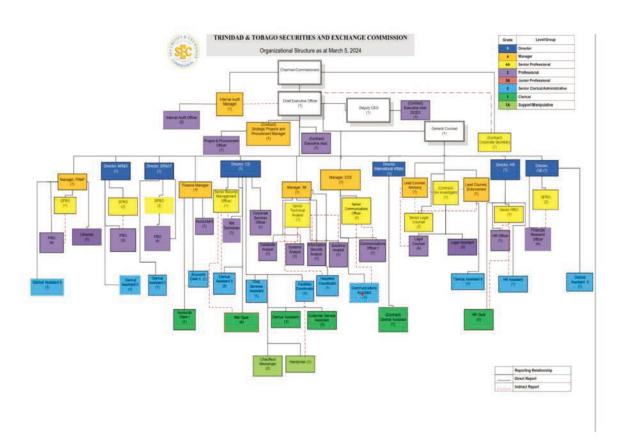
(3) A market actor that is required to furnish information to the Commission in accordance with subsection (2) shall furnish the required information, within the time specified and verified in the manner specified by the Commission.

Structure of the Commission

The SA provides for the appointment of no less than five and no more than nine Commissioners to the Board of the Commission.

The Commissioners are drawn from amongst persons with expertise in legal, financial, business or administrative matters.

Organisational Structure of the Commission

Board of Commissioners

The role of the Board of Commissioners of the Trinidad and Tobago Securities and Exchange Commission is to:-

- Approve registration applications;
- Issue prospectus receipts;
- Take enforcement action against any person for failing to comply with the Act;
- Investor protection;
- Recommend By-Laws to the Minister of Finance;
- Authorising Investigations;
- · Holding administrative hearings; and
- Make Orders including exemption orders.

The Board's responsibilities include:-

- supervising the financial affairs of the organization and approving procurement above a certain level (\$250,000.00)
- ensuring statutory compliance with all applicable laws and monitoring risks;
- overseeing the strategic planning process; and
- ensuring the organization is adequately staffed and monitoring the performance of the CEO.

Members of the Executive Team:

Chief Executive Officer

The Office of the Chief Executive Officer leads the Commission in creating an enabling environment for the growth and development of the local capital market, while establishing frameworks for minimizing systemic risk, promoting confidence within the market, and enhancing regulatory and enforcement cooperation with its local, regional and international regulatory counterparts. The Office of the Chief Executive Officer supports the Board in articulating and promoting a vision of what the Commission will achieve in line with its purpose, powers, authority, functions, deliverables and reporting and compliance requirements as conferred by the Securities Act, 2012 (the Act).

Deputy Chief Executive Officer

The Deputy Chief Executive Officer reports directly to the Office of the Chief Executive Officer. The Deputy Chief Executive Officer works closely with the Chief Executive Officer and provides support by assisting in the regulation of the securities industry to ensure the stability of the financial

system and the protection of investors, and the overall management and performance of the Commission Office of the General Counsel

General Counsel

The General Counsel Heads Legal Division and the Legislative Review Team which has as one of its main functions, to draft/review all legislation, policies, and guidelines that fall within the ambit of the Commission.

Divisions/Departments:

(1) Compliance and Inspections

This is the newest Division of the Commission, which was established in 2014 as a result of the passage of the Securities Act 2012. Its main responsibilities are to:

- Conduct on-site inspections of registrants and self-regulatory organizations, whether routine, for cause or sweep inspections (registrants include: self-regulatory organizations and persons registered under Part IV of the Act, i.e. broker-dealer, investment adviser, reporting issuer and underwriter);
- Issue compliance directions, thus directing a registrant to take measures that are necessary to remedy any course of conduct that is contrary to generally accepted standards of conduct or prudent operation and behaviour; and
- Refer matters for legal enforcement in instances where a person fails to take measures as directed in a compliance direction.

In furtherance of its responsibilities, the Division's major objectives are to:

- o Ensure that registrants are operating in compliance with the legislation;
- Help identify compliance problems and areas of emerging risk, which if they occur can adversely affect investors; and
- o Review allegations of improper practices

(2) Corporate Services

The Corporate Services Division is responsible for managing and executing the following functions: administration, property management, procurement, records management, health and safety, fleet management and security services for the Commission.

(3) Corporate Communications and Education

The Department gets its mandate from Section 6 of the Securities Act 2012 and its goal is to educate and promote an understanding by the public of the securities industry and the benefits, risks, and liabilities associated with investing in securities.

The Department's mission is to promote informed investor decisions and the TTSEC's role as regulator, through all aspects of Corporate Communication, inclusive of Public Education and External Communication. The Division is also responsible for performing the Commission's Public Relations, protocol and Crisis Communication functions. In accordance with the IOSCO principles, the Department coordinates a multi-faceted Investor Education programme designed to provide investors and potential investors with suitable information to guide informed decisions.

(4) Disclosure, Registration and Corporate Finance

The Securities Act 2012 ("the Act") entrusts the Commission with the responsibility to ensure that the requirements of Section 62 (1) of the Act are duly executed and that "no security shall be distributed or listed with any self-regulatory organization unless it is registered with the Commission". DR&CF is responsible for the registration of all self-regulatory organisations, broker-dealers, reporting issuers and investment advisers as well as the securities that they provide. This Division:

- Reviews and processes applications of registrants and self-regulatory organizations.
- Reviews documentation to ensure compliance with the law and best practice.
- Approves the contents of prospectuses, offering circulars or any form of solicitation, advertisement or announcement by which securities are offered for sale to the public.
- Reviews filings by all registrants and self-regulatory organizations and assesses among other things the financial solvency of registrants and self-regulatory organizations.
- o Maintains a register of securities registered by the Commission.
- Makes recommendations to the Commission for the suspension/revocation of registration when persons no longer satisfy the registration requirements.
- Identifies trends and issues that are likely to have an impact on the securities industry and makes appropriate policy recommendations.

(5) Finance

The finance department is responsible for both internal and external financial reporting, as well as annual budgeting. It is also responsible for the receipt and depositing of fees and penalties received from market registrants. Additionally, the department is also responsible for all disbursements made by the Commission. This includes

- Payroll and other staff related amounts.
- Disbursements to vendors, the comptroller of accounts and other third parties.

(6) Human Resource Management

The Human Resource Department is responsible for planning and executing a range of human resource strategies with line managers and plans, co-ordinates and implements the human resource management infrastructure that mutually satisfies the corporate objectives and employee needs.

(7) Information Management

The Information Management Division assesses, develops, manages and supports the technological and data requirements of the Commission's internal and external users by establishing performance measures, business processes, business continuity planning and support, digital and online communications, telecommunications, enterprise resource planning and project management.

(8) International Affairs

This Division plays a key role in driving and supporting the development of policies and strategies to engage with regional, international and other key stakeholders in the securities markets.

(9) Internal Audit

Internal Audit is responsible for assessing the design and the effectiveness of the Commission's system of Internal Controls. This activity is also responsible for reporting compliance issues to the Executive Management and to the Board. The Internal Audit activity provides independent, objective assurance and consulting services that add value and improve the Commission's operations. It helps the Commission to accomplish its objectives by bringing a systematic, disciplined approach to the evaluation and improvement of risk management, controls and governance processes. The Commission's Internal Audit activity is guided by the Department's Charter and reports functionally to the Chairman of the Audit Committee and administratively to the CEO. Further, the Internal Auditors have no authority over, nor responsibility for, the activities they audit.

(10) Legal Division

This Division's key functions include a focus on the corporate strategic and tactical legal initiatives as well as the management of the Commission's legal function.

The Legal Division:

- Provides continuing counsel and guidance on legal matters and on legal implications of all matters.
- Serves as key lawyer/legal advisor on all major business transactions, including acquisitions, divestitures and joint ventures.
- o Decides on selection, retention, management and evaluation of all external counsel.
- Organises and manages the company's internal legal function and staff.
- Assumes ultimate responsibility for ensuring that the Commission conducts its business in compliance with applicable laws and regulations.
- Recommends the commencement of investigations of securities law violations, by the Commission.
- Conducts investigations pursuant to Section 150 of the SA 2012 as amended, into market abuse, market manipulation, insider trading and other securities market contraventions.

(11) Market Regulation and Surveillance

The mandate of the Market Regulation & Surveillance Division is derived from the wider functions of the Commission as contained in Section 6 of the Securities Act, 2012, as amended ("the Act'). This Division:

- Maintains surveillance over the local, regional and international financial sector, (especially in the securities market).
- Ensures that market participants comply with their continuous disclosure obligations and reviews compliance with prudential and reporting standards.
- Conducts inquiries into suspected illegal market manipulation and/or brokerage activities.
- Monitors the operations of all Self-Regulatory Organizations registered by the Commission in order to determine their compliance with the applicable Acts and Rules that govern their participation in the Trinidad and Tobago capital market.
- This Division's purpose is to monitor the local capital market with a view to fostering compliance with the Securities Act, 2012 as amended and relevant provisions of other subsidiary legislation.
- In broad terms, the activities of the Division are geared towards monitoring and evaluating the actions of registered or non-registered entities/persons with a view to determining whether such actions contravened, is contravening or may contravene the Act, any By-laws or other guidance issued by the Commission.

(12) Policy, Research and Planning

The Policy, Research and Planning Department is a centralised function which performs the following:

- Conducts research on matters related to the local and international securities markets;
- o Collect and collates financial and statistical data on market activities;
- o Utilises data intelligence to analyse and report on the economic and financial issues;
- o Monitors the performance of market players and segments;
- o Assesses the potential risks posed to the financial system stemming from activities;
- Provides planning and policy formulation capabilities to strengthen the Commission's capacity to discharge its functions.

The Department has a library that is considered a "Special Library" which houses a collection of books, materials and non-confidential information resources, physical and electronic, on the securities industry and related environments.

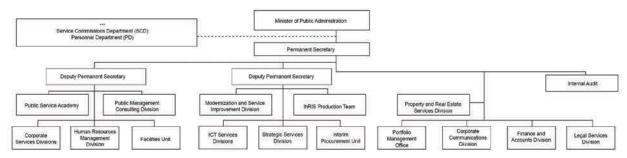

Functions of the Divisions of the Ministry of Public Administration:

CORE DIVISIONS

Integrated Global Payroll (IGP) Integrated Human Resource Information System (ihRIS) was established to support all Ministries in the Public Service in Workforce Administration, Recruitment, Salary Administration Base Benefits, Position Management, Business Rules, Labour Relations, Training Administration, Health and Safety, Performance Management, Competency Management, Succession Planning and Employee Relations.

The Modernization and Service Improvement Division's (MSID) strategic objective is to facilitate a fit-for-purpose and client-centric public service. Accordingly, the MSID develops policies, guidelines and standards, facilitates service improvement in key public services and establishes and operates whole-of-government solutions.

The Property and Real Estate Services Division (PRESD) is responsible for providing mainly office and, to a lesser extent, residential accommodation in accordance with statutory, policy and user requirements for Government Ministries, Departments and Agencies. It manages the portfolio of state-owned properties towards ensuring that these are developed, utilised and maintained to achieve maximum socio-economic returns from assets. The Division has an advisory role to the State on property matters.

The Public Management Consulting Division (PMCD) provides management consulting services to the Cabinet, Government Ministries, Departments and Agencies. Its primary mandate is the review of submissions from Ministries relating to their organizational structures

The Public Service Academy (PSA) is the agency with the primary responsibility for training and development within the Public Service. It aims to maximise the human potential for excellence and high performance through the provision of flexible learning opportunities in collaboration with its strategic partners. The Academy is charged with the responsibility of reviewing the Training Plans of Ministries and Departments. The Academy also administers offers of Technical Cooperation Training from foreign governments and international agencies.

SUPPORT DIVISIONS/UNITS

Corporate Communications Division is responsible for developing and guiding the Ministry's Corporate Communications Strategy. Its activities include Internal Communications, Public Relations, Media Relations, Events Management, Branding, Crisis and Issues Management. The Division's primary purpose is to enhance the image and reputation of the Ministry and to help establish and maintain beneficial dialogue and understanding between the Ministry and its main stakeholders both internally and externally.

Corporate Services Division provides a range of administrative and internal services (office management, file/document registry, and customer service) that support the business goals of the Ministry and contributes to its efficiency.

The Executive Secretariat comprises the Honourable Minister, Minister in the Ministry, the Permanent Secretary, the Deputy Permanent Secretary and the Administrative Support Teams who assist them. The Executive Secretariat is responsible for the oversight of all strategic initiatives, projects and financial decisions within the Ministry, which includes reviews and submission of Notes for the consideration of Cabinet which have been prepared by Divisions/Units and receives and distributes Cabinet Minutes for action or information within the Ministry.

Facilities Unit provides services and support related to the maintenance, upgrades, asset management and security of property occupied by the Ministry.

Finance and Accounts Division is responsible for the financial management practices and procedures of the Ministry. The Division processes payments for suppliers and payroll for employees with the attendant financial recording. The Division also coordinates the submission of budgets and prepares the Ministry's financial statements

The Human Resource Management Division aims to enhance the Ministry's effectiveness and capability to provide excellent client and customer services by retaining and building a human resource skills/knowledge/behaviour base which can deliver on the Ministry's mandate. The Division has as its core functions recruitment of contract personnel, performance management, organisational development, training and development and employee relations.

Information Communication Technology Services Division is responsible for coordinating and providing strategic and operational support for internal Information and Communications Technology projects and systems.

Internal Audit ensures that there is accountability, efficiency and transparency in the financial operations of the Ministry. The Unit is responsible for audit reviews of the Ministry's activities and accounts.

The Interim Procurement Unit was established in October 2017 in preparation for the full proclamation of the Procurement Act No. 1 of 2015. The Unit is responsible for the prequalification of suppliers and the procuring of all goods and services for the Ministry.

Legal Services Division performs general transactional legal work and provides legal advice and support to the Ministry, its various Divisions/Units, and other agencies which fall under its purview.

Portfolio Management Office (PMO) was established on March 22, 2021 and is responsible for the delivery of the Ministry's strategic and mission critical projects inclusive of the Development Programme. This is advanced through the adoption of a standard approach to portfolio, program and project management. The PMO further ensures key information is exchanged seamlessly between the Executive, Heads of Divisions/Units and other stakeholders to effectively proritise, make investment decisions and manage the Ministry's portfolio of projects.

Strategic Services Division is responsible for coordinating the Ministry's Strategic Plan and developing various internal policies. The Division collaborates with the other Divisions/Units in the Ministry and agencies under the purview of the Ministry to monitor and evaluate/ measure performance and meet statutory reporting requirements.
