- The registration certificate of the agency expired during the quarter ended December 31, 2023 and had not been renewed prior to expiration; and
- The registration certificate of the agency expired during the quarter ended December 31, 2023 and the agency re-registered under the Act during the following quarter commencing January1, 2024.
