Time Limit

The Freedom of Information Act mandates that the Commission shall have thirty (30) calendar days to respond to the request made. In the event that the Commission is of the view that additional time is required to obtain the information for the applicant, the Commission shall request from the applicant, in writing, an extension of time.

Fees and Charges

Section 17 of the Freedom of Information Act stipulates that no fee shall be charged by a public authority for making of a request for access to an official document.


