- the maintenance and control of any home for the aged established by the Corporation.
- The processing and granting of final approval for building plans and land development proposals.

- Provision of advice on land development, planning permission, and construction.
- The issuance of Completion Certificates upon inspection for compliance with Town and Country Planning provisions.

- The distribution of truck-borne water subject to the provisions of the Water and Sewerage Act (Chapter 54:40).
- The construction and maintenance of all drains and watercourses, except main watercourses and highway watercourses.
- The promotion of development within the Municipality in accordance with the plans approved by the Minister with responsibility for physical planning.
- The maintenance, control, and enhancement of the physical environment.
- The provision of Public Health Services such as, but not limited to: the disposal of waste from public and private property, cleaning of septic tanks, insect, rodent, and vector control, sanitization of Corporation Assets, the dissemination of information for the public's health.
- The maintenance and repair of taxi stands and benches.
- The provision of charitable assistance from the Chairman's Fund.
- The coordination of local and regional trade fairs, athletic events and cultural displays and entertainment.
- The provision of food badges.
- The collection and distribution of forms issued by Departments of Government.
- The enforcement of the Litter Act, Chapter 30:52
- The enforcement of the Dog Control Act, Chapter 67:56.


The Administrative Arm
