Particulars relating to the offices are outlined below:

1. DIRECTOR OF LABOUR ADMINISTRATION (RANGE 68)

Minimum Experience and Training Requirements:

Extensive (over eight (8) years) experience in the field of Labour Administration such as may have been gained in the lower classes and training as evidenced by an approved course in Labour Administration, or any equivalent combination of experience and training.

Distinguishing Features of Work:

An employee in this class plans, directs and coordinates all activities involved in Labour Administration. Work involves directing and coordinating such functions as conciliation and mediation activities, the maintenance of Labour and Factory Inspections Services and also of Manpower and Employment Service operations. Duties also include advising on related policy procedures, conciliating and mediating in the more complex labour disputes and generally fostering sound industrial relations in the economy. General supervision is exercised through Section Heads, over all personnel engaged in related activities; an employee exercises a high degree of initiative and independent judgment in the performance of his duties. Work is subject to review through discussions with an administrative superior.

2. LABOUR RELATIONS OFFICER I (RANGE 45)

Minimum Experience and Training Requirements:

Considerable [four (4) to eight (8) years] experience in Labour Relations or other related field and training as evidenced by the General Certificate of Education, Ordinary Level or equivalent with passes in five (5) subjects including English Language and Mathematics; supplemented by the successful completion of an in-service training course in Labour Relations or a related field; or any equivalent combination of experience and training.

Distinguishing Features of Work:

An employee in this class assists in conciliation activities between labour and management arising out of "Rights" Disputes in small Industries and/or non-essential services. Work involves visiting industrial and commercial houses to collect relevant information as required, encouraging parties to dispute and come to a voluntary agreement, acting as a third party in complaints between management and individual non-unionised workers, preparing related reports and observing and assisting generally in conciliation activities in "interest" disputes.
