APPOINTMENT OF A CUSTOMS AREA
(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I Yasmin Harris, Acting Comptroller of Customs and Excise, acting under the provisions of Section 2 and 263(3) of the said Act, do hereby appoint the place specified in the Schedule hereunder be a Customs Area, in the use of the Ministry of Energy and Energy Industries on behalf of the Government of Trinidad and Tobago, for the storage of petroleum products, which may be deposited, pending entry for home consumption or export.

SCHEDULE

An enclosed compound situated at No. 55 Frederick Settlement, Caroni, measuring 136 metres wide by 636 metres long and encompassing an area of approximately 8.65 hectares. The compound is bounded on the north by the Caroni Savannah Road and on its southern, eastern and western sides by lands belonging to the State. The entrance to the compound is accessed via a gateway along the south eastern perimeter fence. To the right of the entrance is a "Staging Area" for the use of Road Tank Wagons (RTW's) and north of the said "Staging Area" is a "Truck Maintenance Area". Located adjacent to the western perimeter fence of the said compound are two (2) cylindrical tanks named D-202A and D-202B located north and south of each other with each having a capacity of 32,000 barrels to be used for the storage of Gasoline 95 Ron. Immediately east of tanks D-202A and D-202B are tanks named D-201A and D-201B located, north and south of each other, having a capacity of 46,000 barrels to be used for the storage of Gasoline 92 Ron. Immediately east of tanks D-201A and D-201B are tanks named D-204A and D-204B, located north and south of each other, having a capacity of 55,000 barrels each, to be used for the storage of Diesel. Immediately east of tanks D-204A and D-204B are three (3) tanks positioned in a triangular pattern named D-203A, D-203C and D-203B, with each having a capacity of 17,500 barrels to be used for the storage of Jet A-1. Immediately east of tank D-203B are two (2) tanks named D-205 and D-206 located north and south of each other, each having a capacity of 5,000 barrels, to be used for the storage of "high flash" and "low flash" slop (mixtures of fuels) respectively. Also, along the northern perimeter fence and immediately west of the Sub-Station is one (1) cylindrical tank named D-220, having a capacity of 15,000 barrels to be used for the storage of "Fire Water" (water for use in case of a fire) and immediately west of tank D-220 is tank named D-221 having a capacity of 3,024 barrels used for the storage of potable water. Immediately east of tank D-220 is a tank with a capacity of 500 gallons for the storage of Diesel for the use of the "Fire Water" pump. Immediately east of the "Fire Water" pump and south of a building housing an emergency generator is a tank with a capacity of 3000 gallons for the storage of Diesel for the use of the Emergency Generator. Immediately north-west of the entrance of the said compound is a Fuel Loading Gantry made up of 15 Loading Bays for dispensing Fuels to Road Tank Wagons (RTW's).
