In the event of the election being contested the poll will take place between the hours of 6.00 a.m. and 6.00 p.m. on the 17th day of June, 2024 and as soon as possible thereafter the preliminary results of the poll will be announced at the said place.

If no written request is received by the Returning Officer by 12.00 noon on the 18th day of June, 2024 the Returning Officer shall confirm the result revealed by the statement of the poll from all the polling stations and the count of the special poll and declare the candidate recorded as having received the most votes to be elected.

In the event that a request is received for a final count such count shall be conducted at the office of the Returning Officer on the 18th day of June, 2024 commencing at the hour of 3.00 p.m. and thereafter the number of votes given for the several candidates will be determined in accordance with the Election Rules.
