Minimum Experience and Training Requirements:

A minimum of five (5) years experience in an analytical laboratory including experience in a supervisory capacity and training as evidenced by a BSc degree in one of the natural sciences or engineering from a recognised university, supplement by a MSc degree in Occupational Hygiene from a recognised university and membership of a recognised professional body of Occupational Hygienists or any equivalent combination of experience and training.

Distinguishing Features of Work:

Responsible for planning, directing and administering all the activities of the Occupational Hygiene Division. Work involves supervising a staff of professional and technical assistants engaged in taking samples, carrying out surveys and making a wide variety of analyses for the purpose of monitoring the working environment to enforce the Pesticides and Toxic Chemicals Act and the proposed Occupational Health and Safety Act. Work is performed with a high degree of independence and initiative but is subject to administrative review through discussion and reports.
