Particulars relating to the office are outlined below:

Minimum Experience and Training:

Some (6 to 18 months) clerical experience and training as evidenced by a General Certificate of Education, Ordinary Level, with passes in five subjects, two (2) of which must be English Language and Mathematics and supplemented by evidence of having successfully completed an Induction Training Course for Immigration Officers.

Distinguishing Features of Work:

An employee in this class is responsible for performing a wide variety of routine immigration inspection work. Work involves checking of travel documents of travellers such as tourist cards, passports and visas. Duties are generally performed on a shift basis to accommodate airline and shipping schedules. Work necessitates interviewing travellers and carriers' crew, clearing all carriers for conformance to applicable immigration quarantine and harbour laws and dealing with prohibited immigrants. Some of the tasks assigned are routine and repetitive and after once being learned can be carried on independently under the general supervision of a superior whom employee consults on difficult problems encountered in the course of work.

2025 UPDATED PUBLIC STATEMENT OF THE FAIR TRADING COMMISSION IN COMPLIANCE WITH SECTIONS 7, 8 AND 9 OF THE FREEDOM OF INFORMATION ACT, 1999 (FOIA), CHAPTER 22:02

In accordance with Sections 7, 8 and 9 of the Freedom of Information Act, Chap 22:02 ("FOIA"), the Fair Trading Commission (hereinafter referred to as "the Commission") is required to publish and annually update the following Statement, which lists the documents and information generally available for public scrutiny.

The FOIA gives members of the public a legal right:

1. For each person to access official information held by the Commission;

For each person to have official information relating to himself/ herself amended where it is incomplete, incorrect or misleading;

3. To obtain reasons for adverse decisions made by the Commission regarding an applicant's request for information under the FOIA; and

4. To complain to the Ombudsman and to apply to the High Court for judicial review to challenge adverse decisions made under the FOIA.

The Commission publishes this statement as at March 26th, 2025 in accordance with Sections 7, 8 and 9 of the FOIA .

SECTION 7 STATEMENTS SECTION 7(1) (a) (i) Functions and structure of the Commission

Functions of the Commission

The Commission is a body corporate established pursuant to the Fair Trading Act, Ch. 81:13 ("the Act"). The Act was partially proclaimed in 2007. The Commission was formally established in July 2014. While some sections were proclaimed in the intervening years, all remaining sections of the Act were proclaimed by Her Excellency the President on February 10th, 2020.

The Commission's main functions, as outlined in Section 5 of the Act are to:

(a)Carry out subject to section 9, on its own initiative or at the request of any interested person, such-

 (i)investigations in relation to the conduct of business, as will enable it to determine whether any enterprise is engaging in business practices in contravention of this Act and the extent of such practices; and

 (ii)other investigations as may be requested by any interested person or as it may consider necessary or desirable in connection with matters falling within the provisions of this Act;

(b) Advise the Minister on such matters relating to the operation of the Act, as it thinks fit or as may be requested by the Minister;

(c) Investigate on its own initiative or at the request of any person adversely affected and take such action as it considers necessary with respect to the abuse of a monopoly power by any enterprise; and

(d) Carry out such other duties as may be prescribed by or pursuant to the Act.

Vision

The Vision statement of the Commission is "To create an environment which will be characterized by vigorous competition.".

Mission

The Mission statement of the Commission is "To protect, promote and maintain free and fair competition in the conduct of business in Trinidad and Tobago.".

Duties of the Commission

The key duties of the Commission pursuant to Section 5(2) of the Act include:

(a)To make available— (i) to persons engaged in business, general information with respect to their rights and obligations under the Act; and (ii) for the guidance of consumers, general information with respect to their rights and obligations under the Act or affecting the interests of consumers;

(b) To undertake studies and publish reports and information regarding matters affecting the interests of consumers; and

(c) To co-operate with and assist any association or body of persons in developing and promoting the observance of standards of conduct for the purpose of ensuring compliance with the provisions of the Act.

Structure of the Commission

Section 26 of the Act provides for the Constitution of the Commission.

Section 26 provides that the Commission shall consist of not less than three nor more than five Commissioners appointed by the President from among persons appearing to her to be qualified by reason of their knowledge and experience in the fields of law, economics, accountancy, business, management or other relevant professions.

The Act allows for up to five Commissioners. The current Members of the Board of Commissioners are:




