The Port Authority of Trinidad and Tobago wishes to advise that, in accordance with Section 3 of the Disposal of Uncleared Goods Act No. 46 of 1978, Auctioneer Gary Gregoire has been instructed to sell, by Public Auction, uncleared cargo stored at the Port of Port of Spain.

Please note that the date of next sale, Public Auction #158, is scheduled for **Wednesday 9<sup>th</sup> July 2025 at 9:00 a.m.**, with the conditions of the sale as follows:

- 1) All lots will be sold subject to an upset price which will be announced on the day of the sale.
- 2) All lots will be sold on an **"as is, where is"** basis.
- 3) Notwithstanding any law to the contrary, a person who purchases cargo at this Auction, shall be entitled to take delivery upon payment of:
  - a. The purchase price payable to the Port Authority of Trinidad and Tobago.
  - b. Customs Duty plus VAT shall be payable to the Customs & Excise Division at Customs House.
  - c. Any taxes or duties chargeable under any law other than duty imposed under the Customs Act, calculated by reference to the purchase price.
- 4) Payment must be made to the Port Authority of Trinidad and Tobago on the fall of the hammer, either by cash or certified cheque. Debit/ Credit Cards will be accepted.
- 5) Persons failing to comply with condition (4) above will be debarred from further participating in Auction Sales held by the Port Authority of Trinidad and Tobago.
- 6) All auctioned cargo must be removed from the Authority's Compound by the respective buyer/s **within seven (7) working days** subsequent to the Auction Sale. Failing which, Store Rent will be calculated, in accordance with the Tariff of the Port Authority of Trinidad and Tobago.
- 7) Items sold, but not claimed and removed by the respective buyers as per condition (6) above, shall be resubmitted for sale by the Port Authority at the next Auction Sale.
- 8) Employees and their immediate families are ineligible to participate in the Auction Sale.
