## REPUBLIC OF TRINIDAD AND TOBAGO

The Emergency Powers Regulations, 2024

## ORDER

Made by the Minister of National Security in accordance with paragraph 2 of the Schedule to the Emergency Powers Regulations, 2024

## **DETENTION ORDER**

WHEREAS it is enacted by Regulation 15 of the Emergency Powers Regulations, 2024, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2024, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety or the defence of Trinidad and Tobago, it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2024, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Marvin Gonzales, Minister of National Security, am satisfied with respect to CHRISTIAN CURTIS HUGGINS also called "RED ANTS" or "REDDO" or "ANTS" of Light Pole No. 7, Rudolph Charles Link Road, Gonzales, Belmont and also of Light Pole No. 41, Gonzales Trace, Laventille, East Dry River, Port-of-Spain, that it is necessary to provide for his preventive detention with a view to preventing him acting in a manner prejudicial to public safety:

Now, therefore, I, the Honourable Marvin Gonzales, Minister of National Security, in exercise of the powers conferred on me, do hereby order that the said CHRISTIAN CURTIS HUGGINS also called "RED ANTS" or "REDDO" or "ANTS" of Light Pole No. 7, Rudolph Charles Link Road, Gonzales, Belmont and also of Light Pole No. 41, Gonzales Trace, Laventille, East Dry River, Port-of-Spain be detained, and do hereby authorise the Eastern Correctional Rehabilitation Centre located at 26 Kilometre Mark, Churchill-Roosevelt Highway, Santa Rosa, Arima or such other place as I may from time to time direct, as the place where the said CHRISTIAN CURTIS HUGGINS also called "RED ANTS" or "REDDO" or "ANTS" of Light Pole No. 7, of Rudolph Charles Link Road, Gonzales, Belmont and also of Light Pole No. 41, Gonzales Trace, Laventille, East Dry River, Port-of-Spain shall be detained and so kept in lawful custody.

TAKE NOTICE that the ground upon which this detention order is made is as follows:

The detainee, CHRISTIAN CURTIS HUGGINS also called "RED ANTS" or "REDDO" or "ANTS", has been credibly identified as a high ranking member of, and shooter and enforcer for, an organised criminal group known as the Sixx Gang involved in narcotics and firearms trafficking, larceny of motor vehicles, robberies and murders, and as a person intending to engage in violent gang activity including the retaliatory murder of rival gang members with the use of high powered firearms in public places.
