Made by the Commissioner of Police under section 68(1) of the MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (POINT FORTIN BOROUGH DAY CELEBRATIONS) ORDER, 2025

PART I

PRELIMINARY

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Point Fortin Borough Day Celebrations) Order, 2025.
- 2. This Order commences at 6.00 p.m. on Saturday 19th April, 2025 Duration and expires at 6.00 p.m. on Sunday 4th May, 2025.

PART II

POINT FORTIN BOROUGH DAY LAUNCH

- 3. This Part has effect on Saturday 19th April, 2025 between 6.00 p.m. Duration of and midnight.
 - 4. Vehicular traffic is prohibited on—

Vehicular

- (a) Point Fortin Main Road, between Frisco Roundabout and prohibited Hi Lo Roundabout;
- (b) Mainfield Road; and
- (c) School Road, between Nurse Street and Mainfield Road.
- 5. Parking is prohibited on—

Parking prohibited

- (a) Bryce Road;
- (b) Mainfield Road;
- (c) Morris Road;
- (d) Church Road;
- (e) Nurse Street;
- (f) Alleyne Street; and
- (g) School Road.

Entering or Fortin

- 6. Vehicular traffic entering or exiting Point Fortin from Southern exiting Point Main Road shall proceed-
 - (a) along Frisco Roundabout, onto Second Street, onto Canaan Road and onto Richardson Street; or
 - (b) via Bryce Road and onto Guapo-Cap-de-Ville Road.

Relocation of Taxi Stand

- 7. (1) The San Fernando Taxi Stand is relocated to the lay-by on the eastern side of Point Fortin Main Road, approximately five hundred metres north of Frisco Roundabout.
- (2) The Cedros and Erin Taxi Stands are relocated to the car park of the Roman Catholic Church, on the eastern side of Guapo-Cap-de-Ville Road, in the vicinity of the intersection of Guapo-Cap-de-Ville Road and Reid Road.

PART III

POINT FORTIN BOROUGH DAY

Duration of Part III

8. This Part has effect on Saturday 3rd May, 2025 between 4.00 a.m. and midnight.

Vehicular traffic prohibited

- 9. Vehicular traffic is prohibited on—
 - (a) Guapo-Cap-de-Ville Road, between Bryce Road and Richardson Street;
 - (b) Tanner Street, between Bryce Road and Point Fortin Main Road;
 - (c) Point Fortin Main Road, between Reid Road and Tanner Street:
 - (d) Techier Main Road, between Handel Street and Frisco Roundabout; and
 - (e) Bryce Road, between Tanner Street and Guapo-Cap-de-Ville Road.

Parking prohibited

- 10. Parking is prohibited on—
 - (a) Bryce Road;
 - (b) Tanner Street;
 - (c) Reid Road;
 - (d) Atlantic Avenue;
 - (e) Mainfield Road;
 - (f) Morris Road;
 - (g) Church Road;

- (h) Montano Street;
- (i) Nurse Street;
- (j) Alleyne Street;
- (k) School Road;
- (1) Point Fortin Main Road, between Dunlop Roundabout and Refinery Road;
- (m) Techier Main Road, between Handel Street and First Street:
- (n) Second Street, between First Street and Eastern Avenue;
- (o) Eastern Avenue, between Second Street and Point Fortin Main Road;
- (p) Warden Road, between Guapo-Cap-de-Ville Road and Southern Main Road;
- (q) Clifton Hill Road, between Richardson Street, Volunteer Road and Guapo-Cap-de-Ville Road;
- (r) Southern Main Road, between North Trace Junction and Food Crop Road No. 2;
- (s) Sergeant Street;
- (t) George Street;
- (u) Canaan Road; and
- (v) the Emergency Route set out in clause 13.

11. Vehicular traffic shall proceed along—

One-way

- (a) Reid Road, between Point Fortin Main Road and Montano Street, in a westerly direction only;
- (b) Montano Street, between Bryce Road and Reid Road, in a southerly direction only;
- (c) Bryce Road, between Montano Street and Point Fortin Main Road, in an easterly direction only; and
- (d) Point Ligoure Road, between Point Fortin Main Road and Guapo-Cap-de-Ville Main Road, in a northerly direction only.
- 12. (1) The San Fernando Taxi Stand is relocated to the lay-by on Relocation of the eastern side of Point Fortin Main Road, approximately five hundred Taxi Stand metres north of Frisco Roundabout.
- (2) The Cedros and Erin Taxi Stands are relocated to the car park of the Point Fortin Catholic Church, on the eastern side of Guapo-Cap-de-Ville Road, in the vicinity of the intersection of Guapo-Cap-de-Ville Road and Reid Road.

Emergency Route

- 13. In the event of an emergency, vehicular traffic shall exit Point Fortin along one of the following Emergency Routes:
 - (a) exit Techier Main Road, proceed east to Eastern Avenue, north onto Egypt Main Road and onto Southern Main Road to San Fernando;
 - (b) exit Guapo-Cap-de-Ville Road, proceed west onto Reid Road, north onto Egypt Main Road and north onto Southern Main Road to San Fernando;
 - (c) exit Guapo-Cap-de-Ville Road, proceed south onto Warden Road, north onto Pilgrim Street, west onto Gerald Street and north onto Southern Main Road;
 - (d) exit Atlantic Avenue—
 - (i) proceed west onto Reid Road, north onto Egypt Main Road and onto Southern Main Road to San Fernando;
 - (ii) proceed south onto Guapo-Cap-de-Ville Road, west onto Warden Road, onto Pilgrim Street, onto High Street and north onto Southern Main Road; or
 - (iii) proceed further south from Guapo-Cap-de-Ville Road onto San Fernando-Siparia-Erin Road.

PART IV

POINT FORTIN BOROUGH DAY FESTIVAL

Duration of Part IV

- 14. This Part has effect
 - (a) on Friday 25th April, 2025, between 5.00 a.m. and 2.00 p.m.; and
 - (b) between 6.00 a.m. on Friday 2nd May, 2025 and 6.00 p.m. on Sunday 4th May, 2025.

Parking prohibited

- 15. Parking is prohibited on—
 - (a) Bryce Road;
 - (b) Reid Road;
 - (c) Atlantic Link Road;
 - (d) Mainfield Road;
 - (e) Morris Road;
 - (f) Church Road;
 - (g) Montano Street;
 - (h) Nurse Street;
 - (i) Alleyne Street;
 - (j) School Road;

- (k) Point Fortin Main Road, between Dunlop Roundabout and Refinery Road;
- (1) Techier Main Road, between Handel Street and First Street;
- (m) Second Street, between First Street and Eastern Avenue;
- (n) Eastern Avenue, between Second Street and Point Fortin Main Road;
- (o) Warden Road, between Guapo-Cap-de-Ville Road and Southern Main Road;
- (p) Tanner Street;
- (q) Clifton Hill Road, between Richardson Street, Volunteer Road and Guapo-Cap-de-Ville Road;
- (r) Southern Main Road, between North Trace Junction and Food Crop Road No. 2;
- (s) Sergeant Street;
- (t) George Street;
- (u) Canaan Road;
- (v) Wickham Street;
- (w) Guava Road;
- (x) Agard Road; and
- (y) the Emergency Route set out in clause 20.

16. Vehicular traffic is prohibited on—

Vehicular

- (a) Guapo-Cap-de-Ville Road, between Bryce Road and prohibited Richardson Street;
- (b) Tanner Street, between Bryce Road and Point Fortin Main Road;
- (c) Point Fortin Main Road, between Reid Road and Tanner Street:
- (d) Techier Main Road, between Handel Street and Frisco Roundabout; and
- (e) Bryce Road, between Tanner Street and Guapo-Cap-de-Ville Road.

17. Vehicular traffic shall proceed along—

One-way

- (a) Montano Street, between Bryce Road and Reid Road, in a southerly direction only;
- (b) Bryce Road, between Montano Street and Point Fortin Main Road, in an easterly direction only;
 - (c) Point Ligoure Road, between Point Fortin Main Road and

- Guapo-Cap-de-Ville Road, in a northerly direction only; and
- (d) Reid Road, between Point Fortin Main Road and Montano Street, in a westerly direction only.

Traffic route

- 18. (1) Vehicular traffic entering Point Fortin from Southern Main Road shall—
 - (a) proceed in a westerly direction along Reid Road; or
 - (b) turn right onto Techier Road, right onto Canaan Road, right onto Volunteer Road and onto Guapo-Cap-de-Ville Road.
- (2) Vehicular traffic exiting Point Fortin from Guapo-Cap-de-Ville Road shall turn right onto Reid Road and then right onto Point Fortin Main Road.
 - (3) Vehicular traffic shall exit—
 - (a) Techier Main Road, by proceeding east onto Eastern Avenue, south onto Egypt Main Road and east onto Southern Main Road towards San Fernando;
 - (b) Guapo-Cap-de-Ville Road, by proceeding west onto Reid Road, north onto Egypt Main Road and north onto Southern Main Road towards San Fernando;
 - (c) Guapo-Cap-de-Ville Road, by proceeding south onto Warden Street, north onto Pilgrim Street, west onto Gerald Street and north onto Southern Main Road towards San Fernando; and
 - (d) Atlantic Avenue, by proceeding either—
 - (i) west onto Reid Road, north onto Egypt Main Road and east onto Southern Main Road towards San Fernando; or
 - (ii) south onto Guapo-Cap-de-Ville Road, west onto Warden Road, north onto Pilgrim Street and east onto Southern Main Road.

Relocation of Taxi Stand

- 19. (1) The San Fernando Taxi Stand is relocated to the lay-by on the eastern side of Point Fortin Main Road, approximately five hundred metres north of Frisco Roundabout.
- (2) The Cedros and Erin Taxi Stands are relocated to the car park of the Point Fortin Catholic Church, on the eastern side of Guapo-Cap-de-Ville Road in the vicinity of the intersection of Guapo-Cap-de-Ville Road and Reid Road.

- (3) The La Brea, Gonzales, Techier, Egypt and New Village Taxi Stands are relocated to the car park, between Morelow Supermarket and the Traffic Warden Office, located on Southern Main Road, Point Fortin, approximately six hundred metres north of Frisco Roundabout.
- 20. In the event of an emergency, vehicular traffic shall proceed in a Emergency northerly direction from Atlantic Avenue, south onto Point Ligoure Road, west onto Refinery Road, north onto Guapo-Cap-de-Ville Road, west onto Clifton Hill Road, then in a southerly direction onto Volunteer Road, south onto Canaan Road, then in an easterly direction onto Techier Main Road, then in a southerly direction onto Eastern Avenue, and then in an easterly direction onto Point Fortin Main Road towards San Fernando.

PART V

GENERAL

21. Without prejudice to any other liability incurred by the Removal and commission of a traffic violation, vehicles found parked in contravention impounding of vehicles of this Order may be removed by the Police and impounded and dealt unlawfully with in accordance with section 108(1)(b) of the Motor Vehicles and parked Chap. 48:50 Road Traffic Act.
