THE EMERGENCY POWERS REGULATIONS, 2025

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2025

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and, it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to BUREY OSBORNE GHANY also called “WILLY” of 472, La Lune, Moruga and 25, Orange Field Road, La Pastora, Upper Santa Cruz, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety of Trinidad and Tobago:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred on me, do hereby order that the said BUREY OSBORNE GHANY, also called “WILLY” of 472, La Lune, Moruga, and 25, Orange Field Road,

La Pastora, Upper Santa Cruz, shall be detained, and do hereby authorise the Eastern Correctional Rehabilitation Centre located at Santa Rosa, Arima, or such other place as I may from time to time direct, as the place where the said BUREY OSBORNE GHANY, also called “WILLY” of 472, La Lune, Moruga and 25, Orange Field Road, La Pastora, Upper Santa Cruz, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, BUREY OSBORNE GHANY also called “WILLY”, is a member of an Organised Crime Group (OCG) within the legal definition of the Anti-Gang Act, 2021, actively engaged in violent criminal activity. He is involved in firearms concealment and lookout duties for the OCG and possession of firearms. He has demonstrated immediate capacity for armed violence and is an active participant in a plot to initiate a gang war involving reprisal shootings and assaults of rival gangs in public spaces using high-powered rifles. A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2025, is necessary to prevent him from acting in a manner prejudicial to public safety.
