REPUBLIC OF TRINIDAD AND TOBAGO

THE EMERGENCY POWERS REGULATIONS, 2025

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE  
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS  
REGULATIONS, 2025

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and, it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to JAHEIM BONEY also called “KILL MOVES” of 27, Cosmos Street, Coconut Drive, Morvant, and also of 11, Regent Street, Belle Eau Road, Belmont, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety of Trinidad and Tobago:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred on me, do hereby order that the said JAHEIM BONEY also called “KILL MOVES” of 27, Cosmos Street, Coconut Drive, Morvant, and also of 11, Regent Street, Belle Eau Road, Belmont, shall be detained, and do hereby authorise

the Eastern Correctional Rehabilitation Centre, located at Santa Rosa, Arima, or such other place as I may from time to time direct, as the place where the said JAHEIM BONEY also called “KILL MOVES” of 27, Cosmos Street, Coconut Drive, Morvant, and also of 11, Regent Street, Belle Eau Road, Belmont, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, JAHEIM BONEY also called “KILL MOVES” (hereinafter referred to as “the detainee”), has been credibly identified as a close associate of persons known to the police, and is a member of an Organised Criminal Group (OCG) falling within the definition of a gang under the Anti-Gang Act, 2021, (hereinafter referred to as “the Gonzales Faction”) of the Rasta City 7 Gang. Information reveals that he is a trusted member of the gang and has been identified as a suspect in a recent public assassination of three persons.

He is also a suspect in the shooting death of a police officer and a subsequent shooting at the Port-of-Spain General Hospital. The detainee through the OCG is known to have access to a cache of high-powered rifles which are used in the shootings. He together with related persons have imminent plans to carry out several reprisal shootings using firearms in public places. These most recent incidents have given rise to imminent public reprisal shootings which endanger the safety of the public.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2025, is needed as information indicates that he has and intends to act in a manner prejudicial to public safety.
