ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF
THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(PAN ON D' AVENUE) ORDER, 2025

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Pan on D' Avenue) Order, 2025.

2. This Order shall have effect from 4.00 p.m. on Sunday 31st August, 2025 to 2.00 a.m. on Monday 1st September, 2025. ^{Duration}

3. (1) A driver of a motor vehicle shall not park on the following ^{Parking prohibited} roads:

- (a) between Ariapita Avenue and Wrightson Road along—
 - (i) Ana Street;
 - (ii) French Street; and
 - (iii) Carlos Street;
- (b) Colville Street, between Ariapita Avenue and Tragarete Road;
- (c) Maraval Parkway;
- (d) Taylor Street, between Warren Street and Ariapita Avenue;
- (e) Warren Street, between Belle Smythe Street and Rosalino Street;
- (f) Robert Street, between Rosalino Street and Colville Street;
- (g) Hamilton Holder Street;
- (h) O'Connor Street; and
- (i) Belle Smythe Street.

(2) Notwithstanding subclause (1)(c), vehicles conveying steelbands may park on Maraval Parkway.

4. (1) A driver of a motor vehicle shall not proceed or park along Ariapita Avenue, between Belle Smythe Street and Colville Street.

(2) Notwithstanding subclause (1), vehicles conveying steelbands may proceed or park along Ariapita Avenue, between Taylor Street and Colville Street.

Band route

5. Bands shall assemble on Maraval Parkway and then proceed east along Ariapita Avenue until Colville Street, and on completion of their performance will disassemble at the intersection of Colville Street and Ariapita Avenue.

Two-way
traffic

6. A driver of a motor vehicle shall proceed in both directions along the following streets bounded in the north by Warren Street and Roberts Street, and in the south by Wrightson Road:

- (a) O'Connor Street;
- (b) De Verteuil Street;
- (c) Petra Street;
- (d) Gallus Street;
- (e) Alberto Street;
- (f) Rosalino Street;
- (g) Luis Street;
- (h) Alfredo Street;
- (i) Carlos Street;
- (j) Murray Street;
- (k) Fitt Street;
- (l) Cornelio Street;
- (m) Gatacre Street; and
- (n) Taylor Street, between Warren Street and Ariapita Avenue.

Removal and
impounding

7. Without prejudice to any other liability incurred by the commission of a traffic violation, a motor vehicle found parked in contravention of this Order may be removed, impounded and dealt with in accordance with sections 108 and 109 of the Motor Vehicles and Road Traffic Act.
