REPUBLIC OF TRINIDAD AND TOBAGO

THE EMERGENCY POWERS REGULATIONS, 2025

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2025

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and, it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to KEMO YEATES also called “JOCKEY” of Light Pole No. 93, La Retreat Road, Arima, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety of Trinidad and Tobago:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred on me, do hereby order that the said KEMO YEATES also called “JOCKEY” of Light Pole No. 93, La Retreat Road, Arima, shall be detained, and do hereby authorise the Eastern Correctional Rehabilitation Centre, located at Santa Rosa, Arima, or such other place as I may from time to

time direct, as the place where the said KEMO YEATES also called “JOCKEY” of Light Pole No. 93, La Retreat Road, Arima, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, KEMO YEATES also called “JOCKEY”, has been credibly identified as an associate in an Organised Crime Group (OCG) that falls within the definition of the Anti-Gang Act, 2021. He is actively involved in and intends to continue a series of acts that are prejudicial to public safety. These actions include participating in shootings and homicides to re-establish the gang’s dominance in the La Retreat/Arima district, resuming large-scale marijuana trafficking operations, and smuggling contraband like narcotics and cell phones into correctional facilities. The OCG uses threats and intimidation against community members and witnesses to suppress cooperation with law enforcement and maintain control. The OCG is linked to multiple murders and woundings in 2025 and plan to imminently engage in further retaliatory shootings using high-powered firearms in public spaces which pose a clear and present threat to civilian life. His preventive detention is considered necessary to disrupt these plans and prevent future acts of violence.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2025, is necessary to prevent him from acting in a manner prejudicial to public safety.
