REPUBLIC OF TRINIDAD AND TOBAGO

THE EMERGENCY POWERS REGULATIONS, 2025

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2025

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and, it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to AQUIYL MOHAMMED GILES also called “SNAKE MAN” of Sea Trace, Bagatelle Road, Diego Martin and also of Ward Lane Extension, San Juan and also of 54, Ward Lane Extension, San Juan, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety of Trinidad and Tobago:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred on me, do hereby order that the said AQUIYL MOHAMMED GILES also called “SNAKE MAN” of Sea Trace, Bagatelle Road, Diego Martin and also of

Ward Lane Extension, San Juan and also of 54, Ward Lane Extension, San Juan, shall be detained, and do hereby authorise the Eastern Correctional Rehabilitation Centre, located at Santa Rosa, Arima, or such other place as I may from time to time direct, as the place where the said AQUIYL MOHAMMED GILES also called “SNAKE MAN” of of Sea Trace, Bagatelle Road, Diego Martin and also of Ward Lane Extension, San Juan and also of 54, Ward Lane Extension, San Juan, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, AQUIYL MOHAMMED GILES also called “SNAKE MAN” is a member of an Organised Crime Group (OCG) within the legal definition of the Anti-Gang Act, 2021, actively engaged in violent and high-risk criminal activity. He is involved in lookout/escort for stolen vehicles, GPS counter-measures, and firearms conspiracy. He is confirmed to be a conspirator in a planned armed robbery in Toco and in a conspiracy to purchase rifles to murder family members. He is an active participant in the execution of imminent reprisal killings and assaults against rival gangs using high-powered rifles in public spaces. His detention is considered a necessity to prevent him from acting in a manner prejudicial to public safety.
