

LEGAL NOTICE NO. 364

REPUBLIC OF TRINIDAD AND TOBAGO

THE EMERGENCY POWERS REGULATIONS, 2025

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2025

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and, that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to ANISHA LISA RAFFICK also called ANISHA RAFFICK also called ANISHA LAWRENCE of No. 27 Mc Pancham Street, Borde Narve and also of No. 31 Ethel Street, La Romain, that it is necessary to provide for her preventive detention with a view to preventing her from acting in a manner prejudicial to public safety of Trinidad and Tobago:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, hereby order that the said ANISHA LISA RAFFICK also called ANISHA RAFFICK also called ANISHA LAWRENCE of No. 27 Mc Pancham

Street, Borde Narve and also of No. 31 Ethel Street, La Romain, shall be detained, and do hereby authorise the Women's Prison, located at Golden Grove Road, Arouca, or such other place as I may from time to time direct, as the place where the said ANISHA LISA RAFFICK also called ANISHA RAFFICK also called ANISHA LAWRENCE of No. 27 Mc Pancham Street, Borde Narve and also of No. 31 Ethel Street, La Romain, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, ANISHA LISA RAFFICK also called ANISHA RAFFICK also called ANISHA LAWRENCE, has been credibly identified as a member of an Organised Crime Group ("OCG") within the legal definition of the Anti-Gang Act, 2021, known as the "R-Gang". The OCG operates mainly in the Ethel Street, La Romain area and environs and is connected to other larger OCGS. The OCG has access to a cache of high-powered firearms and is involved in narcotics and firearms trafficking as well as money laundering. The detainee is responsible for financial and logistical operations of the OCG. The detainee and others are conspiring to imminently expand their territory by means of shootings in public spaces using high-powered firearms against their gang rivals.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2025, is necessary to disrupt these plans and prevent her from acting in a manner prejudicial to public safety.
