REPUBLIC OF TRINIDAD AND TOBAGO

The Emergency Powers Regulations, 2025

ORDER

Made by the Minister of Homeland Security in accordance with paragraph 2 of the Schedule to the Emergency Powers Regulations, 2025

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and, that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to KERWIN KENUS EADIE also known as "KNOX" of No. 10A Belmont Valley Road, Belmont, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety of Trinidad and Tobago:

Now, therefore, I, Honourable Roger Alexander, Minister of Homeland Security, in accordance with the powers vested in me, do hereby order that the said KERWIN KENUS EADIE also known as "KNOX" of No. 10A Belmont Valley Road, Belmont be detained and do hereby

authorise the Eastern Correctional Rehabilitation Centre or such other place as I may from time to time direct, as the place where the said KERWIN KENUS EADIE also known as "KNOX" of No. 10A Belmont, shall be detained and so kept in lawful custody.

Take Notice that the grounds upon which this detention order is made are as follows:

The detainee, KERWIN KENUS EADIE also known as "KNOX", is the leader of an Organised Crime Group (OCG) known as the "Alien/7" gang, which falls within the definition of the Anti-Gang Act, 2021. He is a central figure in directing the operations of the OCG. This OCG, which has access to a cache of weapons, is currently engaged in a planned takeover of a rival OCG's turf utilising imminent random shootings in public areas. He and others plan to continue a campaign of violence, including armed attacks and retaliatory shootings, in the Belmont area. The OCG has been linked to recent murders and woundings and has a demonstrated intent to conduct further violent acts in public spaces utilising high powered firearms, posing a clear and present threat to civilian life. The OCG also uses threats and intimidation against community members to suppress cooperation with law enforcement and maintain control. The detention of this individual is therefore necessary to disrupt the gang's operational planning and to prevent further acts of violence that pose a clear and present threat to public safety.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2025 is necessary to prevent him from acting in a manner prejudicial to public safety.
