REPUBLIC OF TRINIDAD AND TOBAGO

The Emergency Powers Regulations, 2025

ORDER

Made by the Minister of Homeland Security in accordance with paragraph 2 of the Schedule to the Emergency Powers Regulations, 2025

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and, that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to SHAQUILLE MC INTYRE also known as "DIRTSMAN" of No. 9 Coconut Drive, Mt. Hope Extension, San Juan, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety of Trinidad and Tobago:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, do hereby order that the said SHAQUILLE MC INTYRE also known as "DIRTSMAN" of No. 9 Coconut Drive, Mt. Hope Extension, San Juan, shall be detained,

and do hereby authorise the Eastern Correctional Rehabilitation Centre, located at Santa Rosa, Arima or such other place as I may from time to time direct, as the place where the said SHAQUILLE MC INTYRE also known as "DIRTSMAN" of No. 9 Coconut Drive, Mt. Hope Extension, San Juan, shall be detained and so kept in lawful custody.

Take Notice that the grounds upon which this detention order is made are as follows:

The detainee, SHAQUILLE MC INTYRE also known as "DIRTSMAN", is a known shooter within the Six Gang, which is an Organised Crime Group within the legal definition of the Anti-Gang Act, 2021. The OCG has access to a cache of high-powered firearms. He has been identified by witness recognition and detained on related enquiries. He is actively engaged in an ongoing campaign of retaliatory violence stemming from a narcotics dispute. Intelligence reveals that the detainee and others plan imminent future acts involving the deliberate use of indiscriminate or saturation gunfire into populated residential areas to flush out or kill targets using high-powered firearms, a tactic which has already been operationalised. The detention of this individual is therefore necessary to disrupt an active campaign of retaliatory violence that has already produced fatalities, and to prevent further loss of life and a clear, ongoing danger to public safety in the Mt. Hope and other districts.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2025, is necessary to prevent him from acting in a manner prejudicial to public safety.
