REPUBLIC OF TRINIDAD AND TOBAGO

The Emergency Powers Regulations, 2025

ORDER

Made by the Minister of Homeland Security in accordance with paragraph 2 of the Schedule to the Emergency Powers Regulations, 2025

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and, that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to KELLON KIRTON SORIAS also known as "BLACKA" also known as "KYLE SMITH" also known as "KELLON MALONE SORIAS" also known as "KELON SORIAS" also known as "KELON SORIAS" also known as "KEYLON KIRTON SORIAS" also known as "KESTON KIRTON SORIAS" also known as "KELLON KERTON SORIAS" of Young Street, Scarbrough, Tobago and also of Hummingbird Avenue, Sou Sou Lands, Tobago and also of Hampden, Tobago, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety of Trinidad and Tobago:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, do hereby order that the said KELLON KIRTON SORIAS also known as "BLACKA" also known as "KYLE SMITH" also known as "KELLON MALONE SORIAS" also known as "KELON SORIAS" also known as "KIRTON KELON SORIAS" also known as "KEYLON KIRTON SORIAS" also known as "KESTON KIRTON SORIAS" also known as "KELLON KERTON SORIAS" of Young Street, Scarbrough, Tobago and also of Hummingbird Avenue, Sou Sou Lands, Tobago and also of Hampden, Tobago, shall be detained in the Eastern Correctional Rehabilitation Centre located at Santa Rosa, Arima or such other place as I may from time to time direct, as the place where the said KELLON KIRTON SORIAS also known as "BLACKA" also known as "KYLE SMITH" also known as "KELLON MALONE SORIAS" also known as "KELON SORIAS" also known as "KIRTON KELON SORIAS" also known as "KEYLON KIRTON SORIAS" also known as "KESTON KIRTON SORIAS" also known as "KELLON KERTON SORIAS" of Young Street, Scarbrough, Tobago and also of Hummingbird Avenue, Sou Sou Lands, Tobago and also of Hampden, Tobago, shall be detained and so kept in lawful custody.

Take Notice that the grounds upon which this detention order is made are as follows:

The detainee, KELLON KIRTON SORIAS also known as "BLACKA" also known as "KYLE SMITH" also known as "KELON MALONE SORIAS" also known as "KELON SORIAS" also known as "KELON SORIAS" also known as "KEYLON KIRTON SORIAS" also known as "KESTON KIRTON SORIAS" also known as "KELLON KERTON SORIAS" is a member of an Organised Crime Group ('OCG') within the legal definition of the Anti-Gang Act, 2021, which is the Tobago faction of the Rasta City/Seven Gang. He is senior associate, driver and enforcer of the OCG. He and the OCG have access to a cache of high-powered firearms, advanced telecommunication

devices and sea transport. He and others are conspiring to murder a police officer and members of a rival gang. The group's activities also demonstrate an intent to imminently escalate and facilitate gang violence using high-powered firearms in public spaces. The detention of this individual is therefore necessary to disrupt the group's operational planning and to prevent further acts of violence that pose a clear and present threat to public safety.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2025, is necessary to prevent him from acting in a manner prejudicial to public safety.
