THE ELECTIONS AND BOUNDARIES COMMISSION (LOCAL
GOVERNMENT AND TOBAGO HOUSE OF ASSEMBLY)
(TOBAGO) ORDER, 2025

WHEREAS under section 71 of the Constitution of the Republic of ^{Preamble}
Trinidad and Tobago there is established an Elections and Boundaries
Commission (hereinafter referred to as “the Commission”):

And whereas under section 4(1) of the Elections and Boundaries
Commission (Local Government and Tobago House of Assembly) Act ^{Chap. 25:50}
(hereinafter referred to as “the Act”), the Commission is charged,
inter alia, with responsibility for defining and reviewing the boundaries
of the electoral districts into which an electoral area is, or is to be,
divided:

And whereas in accordance with section 4(2)(c)(i) reports under
subsection (1) shall be submitted by the Commission, in the case of a
report in reference to Tobago, not less than two nor more than four
years from the date of submission of the last report:

And whereas in accordance with section 4(1)(a) and (2)(c)(i) of the
Act, the Commission on the 29th day of August, 2025, submitted to the
Minister a report entitled “*Fourteenth Report of the Elections and
Boundaries Commission on the Boundaries of the Electoral Districts in
the Electoral Area of Tobago*” (hereinafter referred to as “the Fourteenth
Report of the Commission”) in which it recommends, for the purposes of
the Tobago House of Assembly Elections—

- (a) the alteration of the boundaries of two (2) electoral districts in
the electoral area of Tobago, namely; Mason Hall/Moriah and
Bagatelle/Bacolet;

- (b) that the names of two (2) electoral districts be renamed as follows:
 - (i) Mason Hall/Moriah is to be renamed Mason Hall North/Moriah; and
 - (ii) Bagatelle/Bacolet is to be renamed Mason Hall South/Bagatelle;
- (c) that no change be made to the names and boundaries of the remaining thirteen electoral districts in the electoral area of Tobago;
- (d) that the names of the fifteen electoral districts in the electoral area of Tobago should carry the names as shown in Appendix C (i) to the Fourteenth Report;
- (e) that each of the fifteen electoral districts in the electoral area of Tobago should be constituted of the polling divisions shown in Appendix C (ii) to the Fourteenth Report;
- (f) that each of the fifteen electoral districts in the electoral area of Tobago should be described as stated in Appendix D to the Fourteenth Report; and
- (g) that each of the fifteen electoral districts in the electoral area of Tobago should be delineated and defined as described in the composite map attached to the Fourteenth Report as Appendix F and titled The Electoral District Composite Map:

And whereas it is provided by section 4(3) of the Act that as soon as may be after the Commission has submitted a report under section 4(1)(a) of the Act, the Minister shall lay before the House of Representatives for its approval, the draft of an Order by the President for giving effect, whether with or without modifications to the recommendations contained in the report:

And whereas a draft of this Order giving effect to the recommendations contained in the Fourteenth Report of the Commission was, on the 5th day of December, 2025, laid by the Minister before the House of Representatives for its approval and was approved by resolution of the House of Representatives on the 5th day of December, 2025:

Now, therefore, I, CHRISTINE CARLA KANGALOO, O.R.T.T.,

**FOURTEENTH REPORT OF THE ELECTIONS AND
BOUNDARIES COMMISSION
ON ITS DEFINITION AND REVIEW OF THE BOUNDARIES OF THE
ELECTORAL DISTRICTS IN THE ELECTORAL AREA OF TOBAGO**

To:

**The Honourable Khadijah Ameen,
Minister of Rural Development and Local Government,

1. The Elections and Boundaries Commission (the Commission) is pleased to submit to you, as required, its Fourteenth Report on the Definition and Review of the Boundaries of the Electoral Districts in the Electoral Area of Tobago. This review was undertaken in keeping with the Elections and Boundaries Commission (Local Government and Tobago House of Assembly) Act, Chapter 25:50 as amended by the Tobago House of Assembly (Amendment) Act (No. 2 of 2021).
2. Section 4(1) and (2) of the Act provides as follows:
 - “4. (1) The Commission shall define and review the boundaries of the electoral districts into which an electoral area is, or is to be, divided and shall submit to the Minister reports either –
 - (a) showing the constituencies or electoral districts into which it recommends that an electoral area should be divided in order to give effect to the Rules set out in the Second Schedule; or
 - (b) stating that, in the opinion of the Commission, no alteration is required to the existing number of (sic) boundaries of electoral districts in order to give effect to the said Rules.
 - (2) Reports under subsection (1) shall be submitted by the Commission–
 - (a) in the case of its first report after the commencement of this Act, not later than six months after the date of the commencement;
 - (b) in the case of any subsequent report, not less than two nor more than three years from the date of the submission of its last report; and
 - (c) in the case of a report in reference to Tobago–
 - (i) not less than two nor more than four years from the date of submission of the last report;
 - (ii) in the year 2021 for the purposes of the creation of fifteen electoral districts, within ninety days of the Proclamation of the Tobago House of Assembly (Amendment) Bill, 2021; or
 - (iii) where the Assembly remains dissolved after a primary election and no Assembly is constituted, within fourteen days from such primary election, not less than one hundred and four days from such primary election.”

3. The last report on the definition and review of boundaries in the electoral area of Tobago was submitted to the Honourable Minister of Rural Development and Local Government on 30th August, 2021, and consequently, pursuant to subsection 4(2)(c) of the Act, the deadline for the presentation of the instant report is **29th August, 2025**.
4. The Second Schedule of the Act outlines the Rules to be used by the Commission in determining the number of electors for the electoral districts in the electoral area of Tobago, and the critical rules relevant to Tobago, are quoted below.
 - “1. The number of electors in each electoral district of a regional electoral area shall, so far as practicable, be the number obtained by the application of rule 2, but the Commission may, in consideration of rule 3 vary such number provided that in no case shall the number of electors in any one electoral district of an electoral area exceed or be less than the number of electors in any other electoral district of that electoral area by more than twenty-five per cent.”
 - “2. (2) There shall be fifteen electoral districts in the electoral area of Tobago.”
 - “3. In the division of electoral districts in regional electoral areas natural boundaries such as major highways and rivers shall be used wherever possible.”

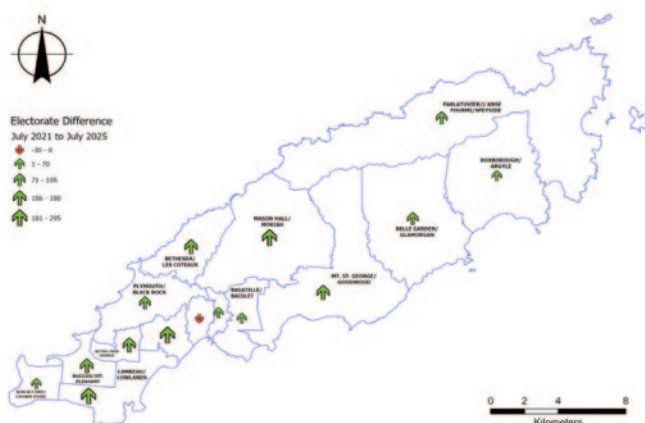
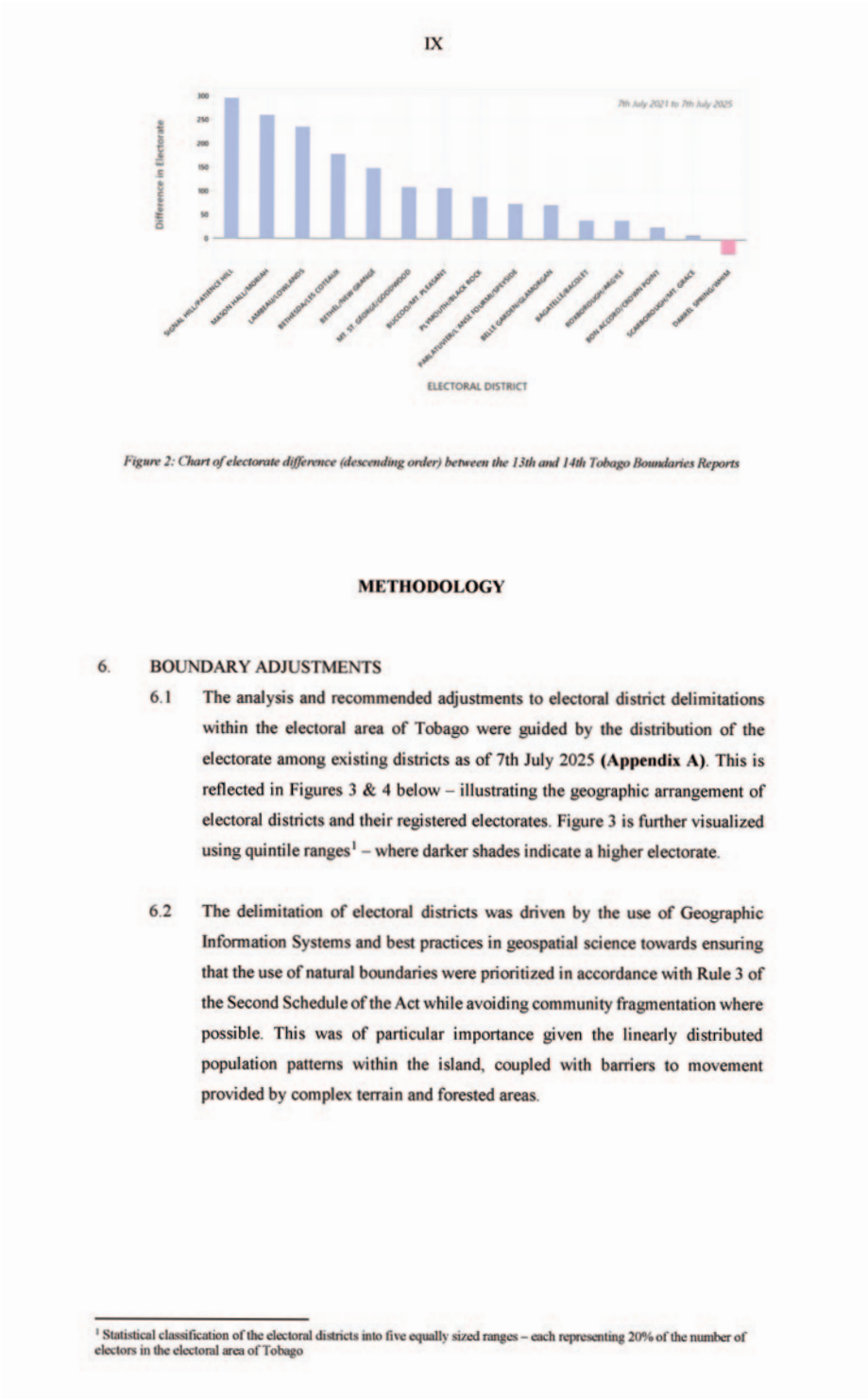


Figure 1: Map of electorate difference between the 13th and 14th Tobago Boundaries Reports

5. In the *Thirteenth Report of the Elections and Boundaries Commission on the Boundaries of the Electoral Districts in the Electoral Area of Tobago*, the electorate in the electoral area of Tobago as it appeared in the Commission's records as at 7th July, 2021 numbered 51,216. The corresponding figure as of 7th July 2025 for the Fourteenth Report is 52,857, thus reflecting an increase of 1,641 electors; equivalent to approximately 3.2% over the former total. This difference is illustrated in Figures 1 and 2.

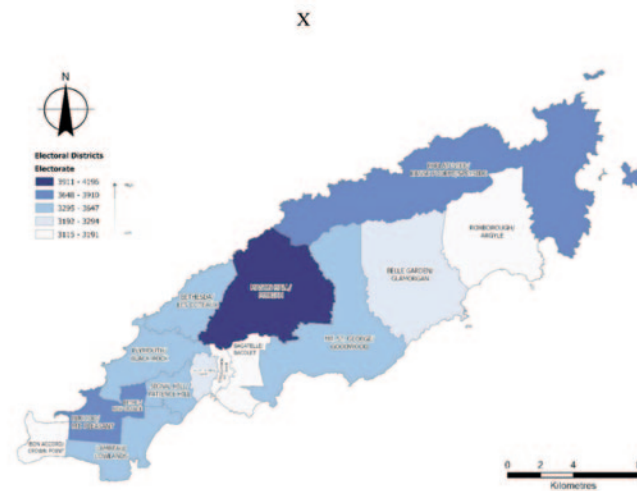


Figure 3: Differences in electorate of the fifteen districts in the electoral area of Tobago

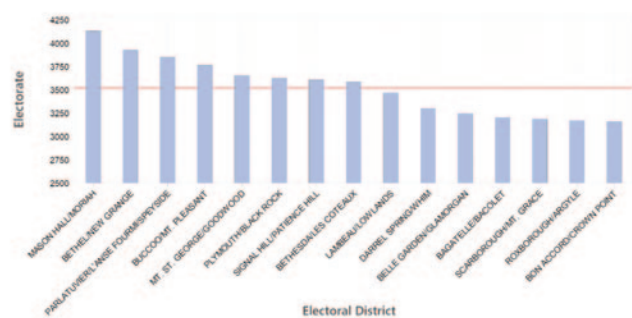


Figure 4: Electoral district electorate (descending order) relative to the 15-district average

7. NOMENCLATURE

Where the Commission considers it appropriate, the names of electoral districts are reviewed to more properly reflect the geographical areas encompassed within them. Subsequent to delimitation adjustments recommended, building patterns were examined using Geographic Information Systems and objectively analysed using the Getis-Ord Gi* algorithm² for each impacted electoral district. These were further coupled with community mappings to evaluate the current district names. This was based on the geographic extent of settlements coupled with its Getis-Ord Gi*

expression for the identification of representative communities – forming the basis of the recommendations for the changes in district names in the instant report.

RESULTS

8. For the purpose of its deliberations, the Commission compared the existing electorate of 7th July, 2021 with that as at 7th July, 2025. The relevant data are set out in the table attached hereto and marked **Appendix B**. The comparison revealed, *inter alia*, that:

- (a) the electorate in the fifteen (15) electoral districts of Tobago rose from 51,216 to 52,857 an increase of 1,641;
- (b) the highest electorate is 4,128, (MASON HALL/MORIAH);
- (c) the lowest electorate is 3,159, (BON ACCORD CROWN POINT);
- (d) the highest electorate exceeds the lowest by thirty point six seven percent (30.67%);
- (e) the lowest electorate is twenty-three point four seven percent (23.47%) below the highest electorate;
- (f) twenty-five percent (25%) below the highest electorate is equal to 3,096; and
- (g) twenty-five percent (25%) above the lowest electorate is equal to 3,949.

9. Therefore, the current electorate of the electoral district of MASON HALL/MORIAH exceeds BON ACCORD / CROWN POINT by 30.67% and the electoral district of BON ACCORD / CROWN POINT is 23.47% below MASON HALL/MORIAH, which does not conform to the Second Schedule of the Act. Consequently, the Commission considers that adjustments are necessary to the existing boundaries of the electoral districts in the electoral area of Tobago.

10. RECOMMENDED ADJUSTMENTS

The Commission recommends that the following Polling Division transfer is necessary to ensure compliance with Rule 1 of the Second Schedule of the Act:

- A. ELECTORAL DISTRICT: MASON HALL/MORIAH
 ELECTORATE: 4,128
 POLLING DIVISIONS: 8 (prior to adjustment)

ADJUSTMENT:

Polling Division 4948 in Mason Hall/Moriah with an electorate of 285 was transferred to Bagatelle/Bacolet, thereby reducing the electorate of Mason Hall/Moriah to 3,843, and the number of Polling Divisions to 7. Collaterally, the electorate of

Bagatelle/Bacolet was increased to 3,489 – bringing both electoral districts into conformity with Rule 1.

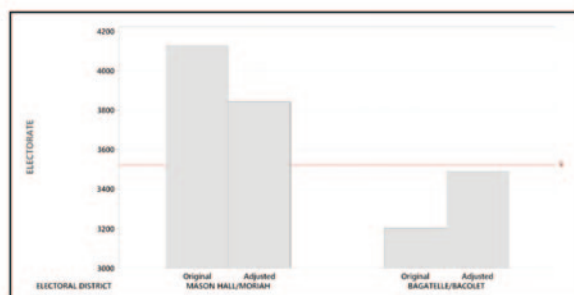


Figure 5: Adjustment impact on electorate for Mason Hall/Moriah and Bagatelle/Bacolet

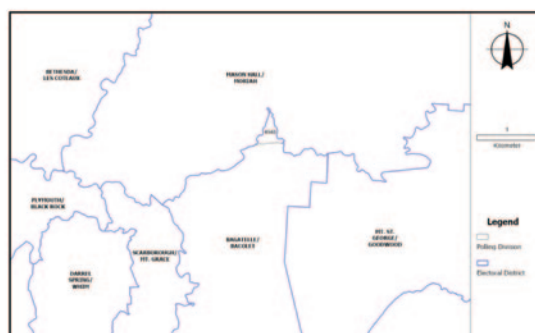


Figure 6: Map of Mason Hall/Moriah and Bagatelle/Bacolet indicating the Polling Division transferred

This adjustment, summarized in Figures 5 and 6 – made at the southern extent of Mason Hall/Moriah, represented a minimal change to ensure compliance with the Second Schedule, while maintaining the use of natural boundaries – in this instance a major roadway and watercourse.

SUMMARY OF ADJUSTMENTS UNDER ‘A’:

- i. Electoral District: Mason Hall/Moriah
Electorate: 3,843
Polling Divisions: 7
- ii. Electoral District: Bagatelle/Bacolet
Electorate: 3,489
Polling Divisions: 10

11. ELECTORAL DISTRICT NAMES

The Commission considered the impact of the recommended boundary adjustments on district nomenclature to best ensure representative communities are reflected in these names. The recommended changes at this time are:

- A. The electoral district of Mason Hall/Moriah is to be renamed Mason Hall North/Moriah.
- B. The electoral district of Bagatelle/Bacolet is to be renamed Mason Hall South/Bagatelle.

Apart from the aforementioned changes to electoral district names, the remaining thirteen electoral districts are not recommended to be renamed at this time.

12. Following the aforementioned adjustments to the delimitation of electoral boundaries within the electoral area of Tobago, it was found that:
 - a. the district with the highest electorate is BETHEL / NEW GRANGE, with an electorate of 3,924;
 - b. the district with the lowest electorate is BON ACCORD/CROWN POINT, with an electorate of 3,159;
 - c. the electorate range between the districts with the highest and lowest number of electors is 765;
 - d. the electoral district with the highest number of electors is 24.21% above the lowest, with the lowest being 19.5% below the highest; and is therefore in compliance with paragraph 4 supra;

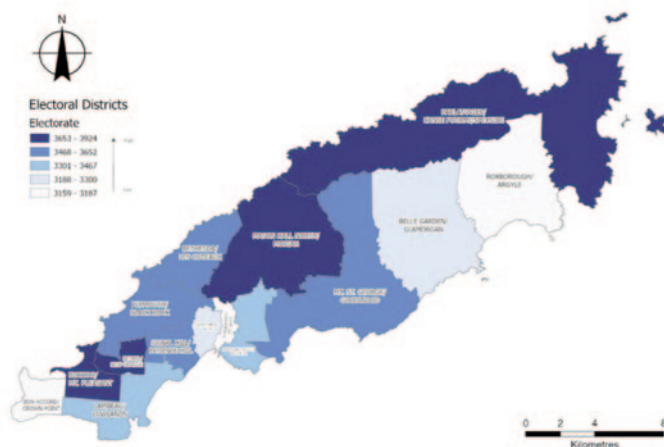


Figure 7: Differences in electorate of the fifteen districts in the electoral area of Tobago after redistribution.

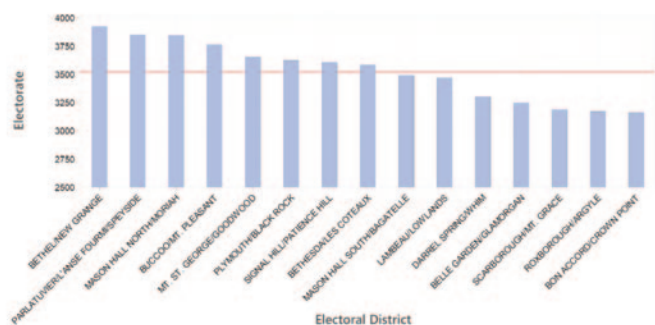


Figure 8: Redistribution of district electorate (descending order) relative to the 15-district average

13. The new distribution of the electorate, relative to the recommended adjustments, are illustrated in Figures 7 and 8.

RECOMMENDATIONS

The Commission therefore recommends as follows:

- i. That no change be made to the boundaries of the following thirteen (13) electoral districts in the electoral area of Tobago:
 - a. Belle Garden/Glamorgan
 - b. Bethel/New Grange
 - c. Bethesda/Les Coteaux
 - d. Bon Accord/Crown Point
 - e. Buccoo/Mt. Pleasant
 - f. Darrel Spring/Whim
 - g. Lambeau/Lowlands
 - h. Mt. St. George/Goodwood
 - i. Parlatuvier/L'anse Fourmi/Speyside
 - j. Plymouth/Black Rock
 - k. Roxborough/Argyle
 - l. Scarborough/Mt. Grace
 - m. Signal Hill/Patience Hill
- ii. Alteration of the boundaries of two (2) electoral districts in the electoral area of Tobago. These are:
 - a. In Mason Hall/Moriah, due to the transfer of Polling Division 4948 from this electoral district to Bagatelle/Bacolet
 - b. In Bagatelle/Bacolet, due to the transfer of Polling Division 4948 from Mason Hall/Moriah.

- iii. That the names of two (2) electoral districts will be renamed. These are:
 - a. Mason Hall/Moriah is to be renamed Mason Hall North/Moriah
 - b. Bagatelle/Bacolet is to be renamed Mason Hall South/Bagatelle
- iv. That the names of thirteen (13) electoral districts will remain unchanged. These are:
 - a. Belle Garden/Glamorgan
 - b. Bethel/New Grange
 - c. Bethesda/Les Coteaux
 - d. Bon Accord/Crown Point
 - e. Buccoo/Mt. Pleasant
 - f. Darrel Spring/Whim
 - g. Lambeau/Lowlands
 - h. Mt. St. George/Goodwood
 - i. Parlatuvier/L'anse Fourmi/Speyside
 - j. Plymouth/Black Rock
 - k. Roxborough/Argyle
 - l. Scarborough/Mt. Grace
 - m. Signal Hill/Patience Hill
- v. That the names of fifteen (15) electoral districts in the electoral area of Tobago, changed and unchanged, should be those outlined in **Appendix C(i)** attached hereto.
- vi. That each of the fifteen (15) electoral districts in the electoral area of Tobago should be constituted of the Polling Divisions shown in **Appendix C(ii)** attached hereto.
- vii. That each of the fifteen (15) electoral districts in the electoral area of Tobago should be described as stated in **Appendix D** attached hereto.
- viii. That each of the fifteen (15) electoral districts in the electoral area of Tobago should be delineated and defined as described in the composite map attached hereto as **Appendix F** and titled *Electoral District Composite Map*.
