Applications for Renewals of liquor licences must be completed on the prescribed Form and accompanied by the following:

1. Copy of Liquor Licence expiring 31st March, 2026;
2. Copy of BIR Number;
3. Copy of Identification Card/Driver's Permit/Trinidad and Tobago Passport;
4. Telephone Contact Number;
5. Email Address; and
6. Gaming Tax Clearance Certificate (if applicable).

All applications must be filed electronically. Applications must be emailed to licensing.chaguanas@ttlawcourts.org in PDF format.

Applications for New Licences should be filed on or before MONDAY 14TH SEPTEMBER, 2026 and Renewals on or before MONDAY 21ST SEPTEMBER, 2026.
