2026 PUBLIC STATEMENT OF THE FAIR TRADING COMMISSION IN COMPLIANCE WITH SECTIONS 7, 8 AND 9 OF THE FREEDOM OF INFORMATION ACT, 1999 (FOIA), CHAPTER 22:02

In accordance with Sections 7, 8 and 9 of the Freedom of Information Act, Chap 22:02 (“FOIA”), the Fair Trading Commission (hereinafter referred to as “the Commission”) is required to publish and annually update the following Statement, which lists the documents and information generally available for public scrutiny.

The FOIA gives members of the public a legal right:

1. For each person to access official information held by the Commission;
2. For each person to have official information relating to himself/ herself amended where it is incomplete, incorrect or misleading;
3. To obtain reasons for adverse decisions made by the Commission regarding an applicant’s request for information under the FOIA; and
4. To complain to the Ombudsman and to apply to the High Court for judicial review to challenge adverse decisions made under the FOIA.

SECTION 7(1) (a) (i)

Functions and structure of the Commission

Functions of the Commission

The Commission is a body corporate established pursuant to the Fair Trading Act, Ch. 81:13 (“the Act”). The Act was partially proclaimed in 2007. The Commission was formally established in July 2014. While some sections were proclaimed in the intervening years, all remaining sections of the Act were proclaimed by Her Excellency the President on February 10th, 2020.

The Commission’s main functions, as outlined in Section 5 of the Act are to:

- (a) Carry out subject to section 9, on its own initiative or at the request of any interested person, such—
 - (i) investigations in relation to the conduct of business, as will enable it to determine whether any enterprise is engaging in business practices in contravention of this Act and the extent of such practices; and
 - (ii) other investigations as may be requested by any interested person or as it may consider necessary or desirable in connection with matters falling within the provisions of this Act;
- (b) Advise the Minister on such matters relating to the operation of the Act, as it thinks fit or as may be requested by the Minister;
- (c) Investigate on its own initiative or at the request of any person adversely affected and take such action as it considers necessary with respect to the abuse of a monopoly power by any enterprise; and
- (d) Carry out such other duties as may be prescribed by or pursuant to the Act.

Vision

The Vision of the Commission is “To create an environment which will be characterized by vigorous competition.”

Mission

The Mission of the Commission is “To protect, promote and maintain free and fair competition in the conduct of business in Trinidad and Tobago.”

Duties of the Commission

The key duties of the Commission pursuant to Section 5(2) of the Act include:

- (a) To make available— (i) to persons engaged in business, general information with respect to their rights and obligations under the Act; and (ii) for the guidance of consumers, general information with respect to their rights and obligations under the Act or affecting the interests of consumers;
- (b) To undertake studies and publish reports and information regarding matters affecting the interests of consumers; and
- (c) To co-operate with and assist any association or body of persons in developing and promoting the observance of standards of conduct for the purpose of ensuring compliance with the provisions of the Act.

Structure of the Commission

Section 26 of the Act provides for the Constitution of the Commission.

Section 26 provides that the Commission shall consist of not less than three nor more than five Commissioners appointed by the President from among persons appearing to her to be qualified by reason of their knowledge and experience in the fields of law, economics, accountancy, business, management or other relevant professions.

The Act provides for a maximum of five (5) Commissioners, comprising a Chairman and four (4) Commissioners.

Staff of the Commission

Members of Staff are appointed by the Commission and include the Executive Director, Senior Legal Counsel, one (1) Investigator, Administrative Secretary and other support staff.

Procedure to be followed when a request for access to a document is made to the Commission.

General Procedure

1. In order to exercise the rights given to applicants under the FOIA, an applicant must make their request in writing by submitting to the Designated Officer either in person or by post:

A completed Request for Access to Official Documents Form, which can be accessed at the Commission's Reception/Lobby area located at Level 09 Nicholas Tower, 63-65 Independence Square, Port of Spain, or which may be downloaded from the Commission's website (<https://tandtftc.org/>) or the Freedom of Information Unit's website (<http://www.foia.gov.tt>).

2. The relevant information that must be provided to the Commission includes the following:

- Name of Applicant
- Contact information for the Applicant
- Information requested and format to provide the information
- Date of request
- Signature of applicant

3. The application should be addressed to the Designated Officer of the Commission. See Section 7 (1) (a) (vi).

4. The applicant will be notified by the Commission's appointed Freedom of Information Officer whether the request was approved or denied as soon as practicable, but not later than thirty (30) days after the day on which the request was received.

5. The Commission will make all attempts to adhere to this time limit, however, if it appears that the processing of the request will not be within the said time limit, the Commission will acknowledge the request and advise the applicant of its status.

6. The possibility exists that requests may be incorrectly addressed or misdirected. Applicants are asked to call or write to confirm that the Commission has received the request, and to ascertain its status.

Details to be included in the request

Applicants should provide sufficient details that will allow for ready identification of requested records. If an applicant is unsure of the way in which a request should be written or the details to be included in the request, the applicant should communicate with the Commission's Freedom of Information Designated Officer.

RESPONDING TO REQUESTS

Retrieving and Furnishing Documents

The Commission is required to furnish copies of documents only when they are in its possession.

A request under the FOIA may not be processed to the extent that it seeks information that is readily available in the public domain, either from the Commission or another public authority, or if the said information is exempted.

The Commission is required to furnish only one copy of a document. If it cannot make a legible copy of the document to be released, it will not attempt to reconstruct it, instead the best copy possible will be furnished.

Requests not facilitated by the Commission

A request under the FOIA will not be facilitated if it is a document which is classified as exempt under Part IV of the FOIA or is a document falling under Section 12 of the FOIA.

Fees and refunds

Section 17(1) stipulates that no fee shall be charged by a public authority for the making of a request for access to an official document. However, where access to an official document is to be given in the form of printed copies, or copies in some form such as a tape, disk, film or other material, the applicant shall pay the prescribed fee.

SECTION 7 (1) (a) (vi)

Designated Officers at the Commission are responsible for:

- (1) The initial receipt of, and action upon, notices under Section 10 of the FOIA;
