**AMENDMENT TO THE TRINIDAD AND TOBAGO RACING AUTHORITY
RULES, 2020, MADE UNDER SECTION 17 OF THE TRINIDAD AND TOBAGO
RACING AUTHORITY ACT, CHAP. 21:50**

Rule 4. Appointment of Stewards

- (1) There shall be at least three Stewards for each race day of every meeting all of whom shall be appointed by the relevant Promoter annually.
