THE EMERGENCY POWERS REGULATIONS, 2026

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2026

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2026, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2026, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2026, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to JOSIAH FULLERTON also called “FILLO” of No. 16 Jack Street, Battoo Boulevard, Marabella, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, do hereby order that the said JOSIAH FULLERTON also called “FILLO” of No. 16 Jack Street, Battoo Boulevard, Marabella, shall be detained at the Eastern Correctional Rehabilitation Centre located at Santa Rosa,

Arima, or such other place as I may from time to time direct as the place where the said JOSIAH FULLERTON also called “FILLO” of No. 16 Jack Street, Battoo Boulevard, Marabella, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, JOSIAH FULLERTON also called “FILLO”, has been credibly identified as a priority offender in the Marabella district in possession of a firearm and ammunition. He has been credibly identified in multiple violent offences, including a shooting with intent, robberies with violence and coordinated gang-related criminal activity. He is a member/associate of an organised criminal network engaged in violent conflict with rival gangs and is involved in the planning and execution of robberies, shootings and home invasions. He has a propensity for serious and violent criminal conduct and is actively involved in the planning of further retaliatory shootings and violent offences in public areas, with the proceeds of crime being used to acquire firearms and ammunition. His detention is necessary to disrupt ongoing criminal operations, prevent imminent violence and protect public safety.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2026, is necessary to prevent him from acting in a manner prejudicial to public safety.
