THE EMERGENCY POWERS REGULATIONS, 2026

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2026

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2026, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2026, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2026, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to KESTER DOLLY also known as “SIX” of No. 140 Farm Road, St. Joseph, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, do hereby order that the said KESTER DOLLY also known as “SIX” of No. 140 Farm Road, St. Joseph, shall be detained at the Youth Training and Rehabilitation Centre located at Golden Grove, or such other place as I

may from time to time direct as the place where the said KESTER DOLLY also known as “SIX” of No. 140 Farm Road, St. Joseph, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, KESTER DOLLY also known as “SIX” has been credibly identified as a member for an Organised Crime Group (‘OCG’)/gang within the definition of the Anti-Gang Act, 2021. The OCG is engaged in violent home invasions, robberies and larceny targeting elderly people in the Northern district. The detainee and others intend to imminently escalate their campaign of violent home invasions, robberies and larceny targeting elderly people and intend to threaten and attack witnesses. His detention is necessary to disrupt these planned attacks and threats.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2026, is necessary to prevent him from acting in a manner prejudicial to public safety.
