THE EMERGENCY POWERS REGULATIONS, 2026

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2026

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2026, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2026, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2026, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to AKIDO WILLIAMS also known as “SUNDAY” of No. 21 Basilon Street, East Dry River, Port-of-Spain, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, do hereby order that the said AKIDO WILLIAMS also known as “SUNDAY”

of No. 21 Basilon Street, East Dry River, Port-of-Spain, shall be detained at the Remand Prison, Golden Grove located at Arouca, or such other place as I may from time to time direct as the place where the said AKIDO WILLIAMS also known as “SUNDAY” of No. 21 Basilon Street, East Dry River, Port-of-Spain, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, AKIDO WILLIAMS also known as “SUNDAY” has been credibly identified as a senior member and factional leader within the 7 Gang (Rasta City faction) which is an Organised Crime Group (‘OCG’) within the legal definition of the Anti-Gang Act, 2021. The OCG has confirmed access to a cache of high-powered firearms and ammunition and is involved in murders, armed robberies, narcotics trafficking and firearm distribution across Laventille and Port-of-Spain. He is involved in directing gang activities including: narcotics trafficking, extortion, and the coordination of violent operations. He is part of an active internal conflict within the gangs, with competing factions engaged in plans to eliminate each other. This conflict significantly increases the likelihood of imminent assassinations and retaliatory shootings in public spaces using high-powered firearms. His detention is necessary to disrupt the gang’s operational capacity and prevent acts prejudicial to public safety.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2026, is necessary to prevent him from acting in a manner prejudicial to public safety.
