THE EMERGENCY POWERS REGULATIONS, 2026

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2026

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2026, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2026, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2026, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to BEVON LEZAMA also known as “B-MAN” of 358, South Seven Street, East Edinburgh 500, Chaguanas, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, do hereby order that the said BEVON LEZAMA also known as “B-MAN” of

358, South Seven Street, East Edinburgh 500, Chaguanas, shall be detained at the Eastern Correctional Rehabilitation Centre located at Santa Rosa, Arima, or such other place as I may from time to time direct as the place where the said BEVON LEZAMA also known as “B-MAN” of 358, South Seven Street, East Edinburgh 500, Chaguanas, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, BEVON LEZAMA also known as “B-MAN” has been credibly identified by confidential intelligence as a member of an Organised Criminal Group (‘OCG’), within the legal definition of the Anti-Gang Act, 2021. The OCG has access to a cache of firearms and ammunition and is involved in armed robberies, shootings, kidnapping, motor vehicle larceny at gunpoint, and trafficking and sale of illegal narcotics. The OCG is linked to transnational OCGs, and the detainee recently assisted a corrupt member of the Police Service to interfere with exhibits of evidential value linked to a transnational OCG from a secure police installation. The detainee’s actions create a significant risk to public safety and his involvement in the transfer of items from police custody and policing information endanger law enforcement and the broader public.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2026, is necessary to prevent him from acting in a manner prejudicial to public safety.
