REPUBLIC OF TRINIDAD AND TOBAGO

THE EMERGENCY POWERS REGULATIONS, 2026

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE  
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS  
REGULATIONS, 2026

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2026, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2026, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2026, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to JASON BENEDICT BROWNE also known as “JASON BROWN” also known as “HULK” also known as “OLD MAN” also known as “BAREFOOT” also known as “ABDUL KAREEM” of No. 3 Queen Street, Aranguez, San Juan, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, do hereby order that the said JASON BENEDICT BROWNE also known as “JASON BROWN” also known as “HULK” also known as “OLD MAN”

also known as “BAREFOOT” also known as “ABDUL KAREEM” of No. 3 Queen Street, Aranguez, San Juan, shall be detained at the Teteron Barracks, Chaguaramas, or such other place as I may from time to time direct as the place where the said JASON BENEDICT BROWNE also known as “JASON BROWN” also known as “HULK” also known as “OLD MAN” also known as “BAREFOOT” also known as “ABDUL KAREEM” of No. 3 Queen Street, Aranguez, San Juan, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, JASON BENEDICT BROWNE also known as “JASON BROWN” also known as “HULK” also known as “OLD MAN” also known as “BAREFOOT” also known as “ABDUL KAREEM” has been credibly identified as the leader of the Sixx Gang, which is an Organised Crime Group (‘OCG’) within the definition of the Anti-Gang Act, 2021. The OCG has confirmed access to firearms and ammunition. The detainee and others are responsible for several recent violent, armed retaliatory attacks on rival gangs. The detainee and others are planning the imminent escape of a known gang member who is presently incarcerated. The detainee and others are planning imminent attacks on prison officers and gang rivals using high-powered firearms in public places. His detention is necessary to disrupt the violent operations of the organised criminal group.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2026, is necessary to prevent him from acting in a manner prejudicial to public safety.
