THE EMERGENCY POWERS REGULATIONS, 2026

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2026

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2026, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2026, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2026, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to ROBINSON NARCIS also known as “ROBBIE NARCIS” also known as “ROBBIE” also known as “R-MAN” of No. 15 Todd’s Road, Caparo and No. 1A Main Road, Caparo Valley Road, Brasso, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, do hereby order that the said ROBINSON NARCIS also known as “ROBBIE NARCIS” also known as “ROBBIE” also known as “R-MAN” of No. 15 Todd’s Road, Caparo and No. 1A Main Road, Caparo Valley Road,

Brasso, shall be detained at the Eastern Correctional Rehabilitation Centre located at Santa Rosa, Arima, or such other place as I may from time to time direct as the place where the said ROBINSON NARCIS also known as “ROBBIE NARCIS” also known as “ROBBIE” also known as “R-MAN” of No. 15 Todd’s Road, Caparo and No. 1A Main Road, Caparo Valley Road, Brasso, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, ROBINSON NARCIS also known as “ROBBIE NARCIS” also known as “ROBBIE” also known as “R-MAN” has been credibly identified as a member of an organised criminal group/gang operating within the Enterprise, Longdenville, Todd’s Road and Caparo districts. The detainee has been actively engaged in a sustained course of extortion, violent intimidation and coercive conduct directed at a civilian victim, including repeated demands for money under threat of serious violence and arson, thereby exercising unlawful control over the victim’s business operations. The detainee has participated in conduct involving threats to kill, coordinated intimidation, and association with individuals engaged in firearm-related criminality and organised gang activity. Recent intelligence indicates that the detainee, together with associates, was actively planning a retaliatory armed attack upon a public business establishment using high-powered firearms, in circumstances demonstrating preparation, coordination and access to the means of carrying out lethal violence in public spaces. The planned use of a stolen vehicle and the targeting of a public venue indicate a real and imminent risk to members of the public. The detainee’s continued liberty poses a serious and immediate threat of armed violence and escalation of organised criminal activity prejudicial to public safety.
