THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(SIPARIA CHILDREN'S CARNIVAL PARADE OF BANDS)
ORDER, 2026

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Siparia Children's Carnival Parade of Bands) Order, 2026. Citation

2. This Order shall have effect in Siparia from 1.00 p.m. to 9.00 p.m. on Friday 13th February, 2026. Duration

3. Vehicular traffic is prohibited from High Street to Victoria Street along Coora Road on the following streets: Vehicular traffic prohibited

- (a) Daisy Voisin Street;
- (b) Edward Street; and
- (c) High Street, between Bermudez Street and La Pastora Street.

4. Parking is prohibited on— Parking prohibited

- (a) Grell Street;
- (b) Gambal Street;
- (c) Oropouche Road, between High Street and Gambal Street;
- (d) La Pastora Street, between High Street and Victoria Street;
- (e) Victoria Street, between Allies Street and La Pastora Street;
- (f) Mary Street;
- (g) George Street; and
- (h) Allies Street, between High Street and Mary Street.

5. Vehicular approaching—

- (a) Siparia from Erin, proceeding to San Fernando, shall be diverted north along the Siparia/Fyzabad Road at the intersection of High Street and the Siparia/Fyzabad Road junction, proceed along the Siparia/Fyzabad Road onto Gambal Street and south onto Grell Street then east onto the San Fernando-Siparia-Erin Road;
- (b) Siparia from San Fernando, proceeding to Erin, shall be diverted north onto Grell Street, onto Gambal Street and east onto Siparia/Fyzabad Road;
- (c) Siparia from San Fernando, proceeding to Fyzabad, shall be diverted north onto Grell Street, onto Gambal Street and east onto Siparia/Fyzabad Road; and
- (d) Siparia from Fyzabad, shall be diverted along Gambal Street onto Grell Street.

6. Taxi stands shall be relocated as follows:

- (a) Erin taxi stand, shall be relocated to the entrance of the Old Siparia Market; and
- (b) Penal and San Fernando taxi stand, shall be relocated to the Daisy Voisin Hub.

7. The Penal and San Fernando maxi-taxi stand, shall be relocated to the Daisy Voisin Hub.

8. Without prejudice to any other liability incurred by the commission of a traffic violation, a motor vehicle found parked in contravention of this Order may be removed, impounded and dealt with in accordance with sections 108 and 109 of the Motor Vehicles and Road Traffic Act.
