REPUBLIC OF TRINIDAD AND TOBAGO

THE EMERGENCY POWERS REGULATIONS, 2025

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE  
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS  
REGULATIONS, 2025

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and, that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to ANTHONY PRINCE of No. 15 Mt. Hope Extension, San Juan, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety of Trinidad and Tobago:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security in exercise of the powers conferred upon me, hereby order that the said ANTHONY PRINCE of No. 15 Mt. Hope Extension,

San Juan, shall be detained and do hereby authorise, in the Eastern Correctional Rehabilitation Centre located at Santa Rosa, Arima or such other place as I may from time to time direct, as the place where the said ANTHONY PRINCE of No. 15 Mt. Hope Extension, San Juan, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, ANTHONY PRINCE is a known affiliate of the Seven Gang which is an Organised Crime Group within the legal definition of the Anti-Gang Act 2021. The OCG has access to a cache of high-powered firearms. He has been recently arrested in connection with a double homicide. Intelligence reveals that he and others intend to imminently avenge the killings of his associates as Seven Gang reprisals against Six Gang affiliates. These planned armed counteractions are intended to be carried out in densely populated areas and pose an imminent and continuing threat to public safety as they include the use and distribution of high-powered firearms and ammunition. The detention of this individual is therefore necessary to disrupt the anticipated counteractions, to prevent further loss of life, and to neutralise a clear, ongoing danger to public safety in the Mt. Hope and other districts.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2025, is necessary to prevent him from acting in a manner prejudicial to public safety.
