REPUBLIC OF TRINIDAD AND TOBAGO

THE EMERGENCY POWERS REGULATIONS, 2025

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2025

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and, it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to TERELL BRATHWAITE of No. 4 Vessigny Village, La Brea and also of No. 25 Bassa Hill Extension, La Brea, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety of Trinidad and Tobago:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred on me, do hereby order that the said TERELL BRATHWAITE of No. 4 Vessigny Village, La Brea and also of No. 25 Bassa Hill Extension, La Brea,

shall be detained, and do hereby authorise the Eastern Correctional Rehabilitation Centre located at Santa Rosa, Arima, or such other place as I may from time to time direct, as the place where the said TERELL BRATHWAITE of No. 4 Vessigny Village, La Brea and also of No. 25 Bassa Hill Extension, La Brea, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, TERELL BRATHWAITE has been credibly identified as a member of an Organised Crime Group ('OCG') within the legal definition of the Anti-Gang Act, 2021, that operates in the La Brea and Guapo districts and which has established links to the Resistance Gang. This OCG is involved in serious criminal activities including, but not limited to, the trafficking of illegal arms and drugs, murder, home invasions, robberies and shootings. The detainee is an enforcer and shooter for the OCG. The OCG has access to a cache of high-powered firearms. The detainee and others intend to imminently escalate attacks against rival gangs in public spaces using high-powered firearms to eliminate rivals and expand territory. The detention of this individual is therefore necessary to disrupt the group's operational planning and to prevent further acts of violence that pose a clear and present threat to public safety.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2025, is necessary to prevent him from acting in a manner prejudicial to public safety.
